CDT is designed to provide diagnostic information in order to guide instruction, intervention, and enrichment. The CDT reporting system is fully integrated with the Standards Aligned System (SAS). The purpose of the CDT is to provide information that will help guide instruction by providing support to students, teachers, and parents. The CDT reports are designed to provide a picture of how students are performing in relation to the Pennsylvania Assessment Anchors & Eligible Content and the Keystone Assessment Anchors & Eligible Content.
