V. APPROVAL OF MINUTES AND AGENDA

ACTION BY THE BOARD:

Motion was made by Douglas Freeman to approve the minutes for the meeting of September 19, 2011, (pages 1-28), and this agenda for October 17, 2011 (pages 1-17), as submitted, with the Board of Education reserving the right to add to the agenda, and take further action on any items raised in executive session where immediate action on such items is considered to be in the best interest of the District. Motion was seconded by Robert Gress and carried unanimously, 7-0.

VI. **ANNOUNCEMENT OF EXECUTIVE SESSION** -- An executive session was held this evening at 6:00 p.m. before this meeting for the purpose of discussing personnel, negotiations and litigation.

VIII. SUPERINTENDENT'S REPORT

A. Mr. Robert Cooke stated that the Monroe Career & Technical Institute met the first Monday in October like they normally do. He stated that the item that provided the most discussion was the funding formula which was rejected by Pleasant Valley. Mr. Cooke stated that the Board had much discussion about that, with the final movement throwing it back to the committee to try to iron out the difficulties with the disagreement that Pleasant Valley was voicing. He stated that, hopefully, they will have some response to that item at the next meeting. Mrs. Laverdure stated that she believes they wanted to wait until after the elections to regroup the committee, if necessary, depending on how the outcome would be. Mr. Cooke stated that he was under the impression, otherwise, but that is fine. Mr. Gress stated that he could not make that meeting but he has concerns that we will be going into another year without saving the half-million dollars. He stated that we know next year will be tough. Mr. Gress stated that this committee will have some slow down on it by putting it to a committee as they say. He stated that there will be a change on the Board down there and they are not going to do anything about it. Mr. Gress stated that Pleasant Valley does not care. He stated that they do not want to pay their fair share

because they made it clear that night and they made it clear at their public meeting. Mr. Gress stated that it was clear that they do not want to pay their fair share. He stated that we should move forward at the next meeting and take them to court if we have to in order for them to pay their fair share. Mr. Gress stated that half a million dollars the last 10 years is 5 million dollars. He stated that the figures are clear. Mr. Gress stated that Pleasant Valley does not want to pay another \$200,000 because they do not have the money to pay it unless they are forced to pay. He stated that the other school districts will probably say no because of how tight their budget is. Mr. Gress stated that we cannot afford a half million dollars for 274 kids that we are sending. He stated that he does not know what the answer is but the committee is not it. Mr. Gress stated that the whole committee voted on it at the meeting but then Pleasant Valley went to their home school district and voted against it. He stated that he could not make it to the last meeting but before that, they were vehemently opposed to it, so he does not know why they recommended it at the MCTI meeting to put it for a vote. Mr. Gress stated that Ms. Kresge, Ms. Micklos and Mr. Gould did not say a word except that they are against it. He stated that it is a half million dollars and the budget is getting cut everywhere and we will lose some things. Mr. Gress stated that he thinks we should file something to let the court decide. He stated that it is a simple formula if you use then you pay. Mr. Gress stated that if we are going to open up the Articles, some did not like it because it is all or nothing, but then we had some concerns we wanted added in. He stated that the agreement will never get approved and it will be another five years. Mr. Gress stated that a half million dollars for this district is a lot of money. Mrs. Laverdure stated that she agrees with Mr. Gress; however, we are bound by the Articles of Agreement. She stated that her concern would be that if we take them to court, they will say that we are bound by the Articles of Agreement. Mrs. Laverdure stated that we will be going around in a circles and the only thing we can do, since it will not kick in until next year, is work through it. She stated that there are two major concerns, the number of students going and making it a minimum number and the cost of running the building. Mrs. Laverdure stated that if there could be a blended formula with a realistic minimum based on the last four years, then they can get some kind of figure as to the cost of running the building. She stated that this may come up with a more realistic number than what we have. Mrs. Laverdure asked Mr. Cooke if he had any thoughts on the matter. Mr. Cooke stated that Mrs. Laverdure spoke to Pleasant Valley so she is aware of what the issues are. Mr. Gress stated that it will not happen until January. Mr. Gress asked what is the date for saying that we will withdraw from the agreement. Mr. Dirvonas stated that he believes it is March 1st. He stated that he believes there is a March date that is provided in the Articles. Mr. Gress asked them to check on that date and let the Board know and we will see what November brings. Mr. Chris Brown confirmed that the date is March 1st. Mrs. Laverdure stated that she appreciates what Mr. Gress is saying but she feels that we have an obligation to educate all of our children regardless of where they are, what they are doing and the career route that they have chosen to take. Mr. Gress stated that he agrees 100% but not at an exorbitant cost. Mrs. Laverdure stated that we got ourselves into this and now we have to somehow work ourselves out of it.

- B. Ms. Hocker stated that she could not attend Colonial IU 20 meeting due to illness. She stated that she brought the monthly IU 20 newsletter for anyone that is interested in the monthly news. Ms. Hocker stated that there are also extra copies available on the table outside of the Board room.
- C. Mr. Cooke stated that the Property/Facilities Committee met at the Lehman campus in the middle of some fog. He stated that Mr. Williams printed the notes from that night and there are copies available on the table outside. Mr. Cooke stated that he would like to call our attention to one thing that Mr. Shearouse approached the committee to talk about, solar energies with a different program. Mr. Cooke stated that the committee thought it was worthwhile for Mr. Shearouse to do some more investigation and bring that information to a future Property/Facilities Committee meeting. Mr. Cooke asked Ms. Hocker if she had any other items. Ms. Hocker stated that she does not have anything else to add because it is all detailed in the notes that were distributed tonight.
- D. Mr. Thomas Dirvonas stated that the Porter Township Initiative appeal that was previously authorized has been filed with the Commonwealth Court. He stated that we have filed the necessary documents and are waiting for further action on behalf of the court as far as a hearing date, briefing schedule so on and so forth; therefore, it is ongoing.
- E. Mrs. Laverdure stated that whenever there is an opportunity to highlight or honor those who have done something phenomenal, we should be able to so at a School Board meeting. She stated that we have a young woman with us, who is a music teacher at East Stroudsburg Elementary School, Lauren Davis, who had a phenomenal opportunity, about two weeks ago, to sing on the floor of the House of Representatives and received a standing ovation. Mrs. Laverdure asked Ms. Davis to explain how she got the opportunity to write this song. Ms. Davis stated that this past summer, she had the opportunity to write a song for 9/11 remembering those who innocently

died in the towers or those who saved others instead of themselves. She stated that a producer, who had received previous music from her because she has a Christian rock band, asked her to write a song for this album. Ms. Davis stated that she wrote the song and they picked it to be the lead song on this album, which is very amazing. She stated that the song is called the Unforgotten. Ms. Davis stated that just by listening to it, you can get a sense of what happened on that day. She stated that if you would like information about the song or about the album or would like to purchase it, you can see her at the end of the meeting. Ms. Davis stated that it represents not only 9/11 but previous wars as well as present wars. Mrs. Laverdure asked what would the money go to. Ms. Davis stated that the money goes to charity for: Wounded Warrior, 9/11 FSA (Families for A Secure America), Landstuhl Hospital Care Project and Operation Troop Aid.

Other Concerns

- A. Dr. Kenneth Koberlein stated that the Commonwealth's Governor recently announced his plans for education in our State. He stated that with the last State budget, our school districts endured reduced financial support and there have been a variety of impacts across the Commonwealth with that reduced State budget. Dr. Koberlein stated that the Governor's plans now include increased taxpayer funds for private and charter schools where public accountability and measures of quality are sorely lacking. He stated that he is speaking tonight to encourage individual citizens, our School Board, as an entity, our School Board as a member of Pennsylvania School Boards Association, our School Administrators individually and through their various organizations, Pennsylvania Association of School Business Officials, Pennsylvania Association of School Administrators, Pennsylvania Association of Elementary and Secondary School Principals, as well as other groups. Dr. Koberlein stated that he is also speaking to the Professional and Support Staff through their organization, PSEA to contact our legislators and to oppose the Governor's recently unveiled plans for education improvement in Pennsylvania. He stated that at a time when our public schools are facing severe economic challenges, our Governor intends to divert significant funding away from public schools. Dr. Koberlein stated to please contact your State Legislators, our legislators and appeal for great public school support. He stated that, we, those who care about Pennsylvania's public schools, should not sit still in silence waiting for bad news. Dr. Koberlein stated to please let our State Legislators know that we need their support. He thanked the Board for all that they do and for anything they will do.
- B. Mr. Gress stated that he thanked Dr. Koberlein for coming up because he forgot to mention it and he appreciates his comments. He stated that he emailed the Governor and Senator Williams from Philadelphia. Mr. Gress stated that Governor Corbett and Senator Williams' contributions, that they got from the special interest groups for charter schools and others, make the Marcelous Shale contributions look like pocket change. He stated that it is important that we call or email the Governor or legislative delegation here to oppose this because they are going to take out more money out of our pot just like they did last year. Mr. Gress stated that he appreciates the number we gave them in the booklet with Board Briefs on Friday. He stated that our district is underfunded about 5-6 million dollars. Mr. Gress stated that everyone keeps saying they gave us more but every year we are underfunded about 5-6 million dollars in basic education subsidies. He stated that Harrisburg spends a lot of time doing things, except addressing the issues that need to be addressed regarding the funding formula. Mr. Gress stated that they just won't address it. He stated that the unveiling of the formula or Governor's proposal is something that will fly sooner than later and they will stick it in just like they do with everything else. Mr. Gress stated that we will be stuck in May cutting programs such as music and other things that we should not be cutting because they are important for our kids. He stated that he emailed the Governor and invited him to visit our schools next time he is in Monroe County and he did not get a response so far. Mr. Gress stated that Senator Williams emailed him back to say that schools in Philadelphia are failing and they need another alternative.
