IX. SUPERINTENDENT'S REPORT

- A. According to Mr. Robert Cooke, Mr. Douglas Freeman and Mr. Robert Gress there was nothing to report on the Monroe Career & Technical Institute monthly meeting.
- B. Mrs. Eileen Featherman said she missed the last Colonial IU 20 meeting due to illness but she passed out the IU 20 Newsletter and will be attending the next meeting this week.
- C. Mr. Robert Cooke said that the notes from the Property/Facilities Committee meeting have been made available to the public and the Board by the secretary, Mr. Williams. He asked if anyone has any questions, they will be happy to answer them.
- D. Mr. Christopher Brown said that there are two quick items on the Porter Township Initiative. One is that they have an application for reconsideration pending before the Commonwealth Court requesting the Commonwealth Court to review it. Number two we would anticipate a State Board of Education hearing and start preliminary preparations for that.
- E. Mrs. Irene Duggins thanked Mrs. Stein and Mrs. Pellington who have been working on integrated activities for the Outdoor Classroom on the North Campus. She asked them to present student Awards for Logo Winners from the Outdoor Classroom Competition. Mrs. Stein announced the winners: Shannon Rosser (Trail Head Sign Design), Alyssa Borges (Trail Learning Station Design) and Monica Clarke (Brochure Logo Design).

Mrs. Duggins said that a High School North Student who attends the Monroe Career & Technical Institute (MCTI) won a trophy for her school. Mr. Zall, Principal of High School North, said that Namansa Marah won first place in an International Championship as part of her Hotel and Lodging Program at the MCTI. Namansa Marah said the American Hotel and Lodging Association hosts competitions for students to compete in Hospitality & Hotel related events. As a result of their winning the team was awarded scholarships, attendance at an inaugural gala for the incoming chairman of the Association and a free trip to New York City for the International Hotel, Motel and Restaurant Show.

F. Mrs. Duggins stated that based on the Elementary and Secondary Education Act and No Child Left Behind, at the June Board meeting, she will be asking the Board to approve the School Improvement plans that High School North, High School South and Bushkill Elementary will be presenting PDE.

Mr. Carty, Principal of Bushkill Elementary, said that in 2011 Bushkill Elementary School successfully met 25 out of 25 annual yearly progress (AYP) targets. We have to do the same this year to exit from the improvement program. He explained the accomplishments of students by grades and academic courses as well as school goals. Mr. Carty explained the steps of actions that are being taken in his school improvement plan. He said everyone on his staff is working hard to achieve these scores.

Mr. Michael Catrillo, Principal of High School South, said that High School South met 25 out of 25 AYP targets in 2011. They have a plan to continue to achieve that success. He said that High School South adopted a model this year, Success for All. He explained High School South's mission, goals and vision for the 2012-2013 school improvement plan.

Mr. Steve Zall, Principal of High School North, said that they have had a steady increase in math and reading for the past four years and are improving in writing proficiency levels. Although they did not meet AYP as outlined by the Commonwealth of PA, they continue to make growth and continue to strive for greater success and performance in administration, staff, and students. He said High School North is often categorized and/or identified by tests scores which is not a true reflection of North High School, so to assist him in recognizing that High School North is more than just scores he called upon some students and their highlights.

- 1. Ricky Johnson received a \$58,000 scholarship to Lehigh University.
- 2. Connor Pellington, team captain of the boys' swimming team, said they took MVC championship this year.
- 3. Tanner Clark, along with the Math League team placed 2nd in Pennsylvania Math Competition.
- 4. Mathew Ingram participated in Pennsylvania Junior Academy of Science competition held at Kings College each year and received a second award.
- 5. Jasmine Jones auditioned at District X and won for piccolo player.

- 6. Cristina Giove was selected as a member of Marywood Honors Band in Scranton, Pennsylvania and is also a drum major who was selected in a featured performance ensemble in the American Wood Band Celebration Festival.
- 7. Chieyen Meachem, member of East Stroudsburg North colorguard and the winning marching band, stated that this year they placed top 5 in the Tournament of Bands and Kappa K. Championship and colorguard also won for top auxiliary.
- 8. Jonathan Shoup won District X for saxophone and performed with District Band and Jazz Ensemble. He also played in the All-State Band.
- 9. Deanna Dunstane, along with the band, received highest rating possible at the Annual Adjudication Festival. They were also selected to march in the National Memorial Day Parade in Washington D.C.
- 10. Nicole Whittaker is part of TSA which is the Technology Student Association and competed in Regionals, States and will move on to Nationals in Nashville, Tennessee.
- 11. Jiana Saigh was recently nominated to become the junior student representative for the Pennsylvania State Board of Education and made it to the top five.
- 12. Marisa Miro along with her team, played for district championship in Field Hockey for first time and will attend University of Iowa with a \$40,000 scholarship. She was the first H.S. North student recipient of the Bill Gates Foundation Scholarship.

Mr. Zall said that their work is not done because there is much to be done to improve all test scores. They will continue to keep their focus on learning.

Mrs. Duggins said that each school is working hard to achieve AYP status. She said next month Mr. John Burrus, J. T. Lambert Intermediate School Principal and Mrs. Irene Livingston, East Stroudsburg Elementary School Principal will present their school improvement plans.

G. Mrs. Patricia Bader brought a handout regarding fund balance timeline. There has been a lot of talk, so she brought a short presentation on how the fund balance was created. She explained the history of the fund balance since 2008 until the current year. She said that the fund balance as of 6/30/11 is as follows:

Note: The Fund Balance is valued once a year on June 30. Our current results appear to be tracking below budget and therefore our Fund Balance on 6/30/12 may increase by an estimated \$3 million.

She said that we believe that we are in a better position than any of the other Monroe County Schools for the future. She explained the PSERs increase due to employer contribution rate increases which we have \$9.1 million set aside for PSERs. If we do not raise taxes, we will use this money in just under two years.

She brought a snapshot of the proposed budget since January with ending today at a 2.3% tax increase. It has a balanced budget and there was a list of cuts which were moved into this proposed final budget except for the half day kindergarten. She explained how we can use the fund balance to offset any increases for our taxpayers. She cautions that we should never use fund balance for ongoing expenditures but it can be done. East Stroudsburg Area School District has a long history of having the pendulum swing back and forth with low fund balance and having to refinance the debt. The last page on Mrs. Bader's presentation was an analysis of increase in millage.

Mr. Horton inquired as to the status of 2011-2012 tax collection and the relationship between collections and a possible tax increase. Ms. Bader responded.

Mr. Meachem said the fund balance is in a position to help and he would like to encourage his fellow Board members to consider using the fund balance to ease the taxpayers' burden.

Other Concerns

- A. Ms. Lorna O'Farrell, for State Representative Rosemary M. Brown, said she is actively fighting for fair funding. She is concerned that her efforts are in vain due to districts' large fund balance. She commended the district for their savings but suggested that the district turn to their savings and not to the taxpayers to fill this gap. She said Mrs. Brown will continue to fight for adequate funding, stronger spending control measures such as prevailing wage reform and work diligently to help address our State pension crisis issue.
- B. Mr. Tom Herb had concerns with the advertisement of this meeting. Mrs. Laverdure said they are publicized on the website, each building, and the Pocono Record. He said he had suggested at a previous meeting how to save money but no one looked into it. He asked if anyone looked into wind energy. Mrs. Laverdure said they had experts look into it but they can do partial but the amount they would need to run this campus would be astronomical. He suggested asking other people who are doing it. Mr. Gress said the Property/Facilities Committee had a company come in but there were not tax breaks and not enough savings but they can revisit the issue. Mr. Horton thanked those who got the word out to inform everyone about tonight's meeting.
- C. Mr. Gary Summers commended Mrs. Bader and her financial team for building a strong financial position for the school district and for sharing the target that is so close to a no tax increase which would be \$1.8 million. He said in his opinion they have a reason, justification and opportunity within the fund balance to find the \$1.8 million that we can use to balance the budget without a tax increase.

- D. Mr. Joseph Mahoney said that a tax increase does not solve problems but makes it worse. He said if there is a tax increase then the foreclosure rates will increase. He said we have the reserve to prevent this. He also suggested an operational accounting.
- E. Mr. Hal Harris thanked Mr. Meachem for standing up and saying that they need to do something besides shifting the burden on to the homeowners and residents of the community. He hopes he will hear that same thing echoed from all Board members. He spoke about the tax appeal filed by Pocmont and pleaded that it not be done for Fernwood. He suggested not shifting the cost to parents and students in making them pay for drivers' education and activities. He also suggested to consolidate and sell property like the North campus to raise some funds, bring jobs and cut expenses.
- F. Mr. Troy Miller asked since there is a 2.3% proposed tax increase will there be a 2.3% increase for teachers contributing to their health care and/or pension fund. He asked if in the next three years will their contributions be 25% to their pensions. He said the 2.3% is outrageous because they are already hurting to pay all expenses, especially when the fund balance is \$35 million.
- G. Ms. Laurie Favini distributed letters to the Board from students from the J. T. Lambert Spring Production who wanted the Board to know what this means to them. The students are from 6-8 grades and asked how is the activity fee going to affect these students, since 6th graders are not being asked to pay activity fees. She said each student is charged a fee for various items and some cannot pay that amount. Ms. Favini suggested that the Board before they vote on implementing an activity fee, ask themselves how will this affect the students rather than how it will affect the budget.
- H. Ms. Theresa Treglia said as the Board raises taxes it puts burdens on taxpayers. She asked the Board to freeze their salaries and have employees pay more into their medical plan. Mr. Searfoss said the Board does not get paid. Mrs. Laverdure said that for the past three years Mrs. Duggins, Mrs. Bader and she have not received a raise. She said the administrative team took a freeze this year. Mr. Meachem said that you cannot believe everything you read in the press because everything she is speaking about is under consideration. Mr. Gress said that the Board may not agree in some things but in other things they do. Ms. Treglia said an AA tax increase would only be warranted if the district was in the top 10%. Mr. Gress said they should come every month because every meeting has an effect on the budget.
- I. Ms. Nadia Worobij said that she is proud of the students from High School North who stated their achievements in the arts, academics and athletics due to the support of the parents, staff, administrators and Board members. She said she would like to honor Mr. Carty, who is retiring, for all of his achievements in the school district.
- Mr. Geofrey Gambill said that the administrators and Board have done an admirable job in balancing the budget for the next school year considering where they started in the spring. He is glad that it does not include a closing of a school. He is aware that the fund balance is allocated for expenses and is a safety net. He spoke about the taxes that Fernwood owes and said there is a chance that the taxes will be paid next year and suggested the district dip into the fund balance now to lower taxes or eliminate it as well as the activity fee. He said taking \$3.4 million from the fund balance would accomplish three things 1. Taxpayer relief; 2. Schools kept opened and 3. Time for Legislators' action at the State level to address funding and equity and hopefully another year for the economy to improve. He suggested borrowing from the fund balance to be paid back when Fernwood pays their back taxes. Mrs. Bader said that this budget increased the tax collection rate assuming they are getting 2011/2012 and 2012/2013 school year taxes from Fernwood. Mr. Horton said he received letters from taxpayers and students about issues being spoken about. He would love to see these letters directed to Fernwood owners since they are our biggest debt in tax collection. He said that we wouldn't need the \$3.5 million from the fund balance but about \$1.8 million to \$2.0 million. Mr. Meachem said that Mr. Gambill said not to close a school and if it is not necessary but we need to improve the process not to consider these issues. He would like to get it to the point to never raise taxes or close a school but it is not going to happen, so they will do the best that they can. He asked the public to continue coming and they will find a solution together because they have come a long way. Mr. Bradley said that Fernwood is not the only one that is remiss in making their payments but there are others that owe money. He would like the money taken from the fund balance to pay our deficit and reinstate programs and add programs that are needed for the children.
- K. Mr. Paul Miller (on behalf of the High School North Band Parent Organization) thanked the Board for allocating funds for a trailer and truck to carry equipment for band competitions and football games. They own a box truck that is in poor condition and not drivable. The parent organization would like to use these funds to purchase an 8 x 16 cargo trailer and in order to pull the trailer, they will need a heavy duty truck. Since the district does not own a heavy duty truck, they would like to purchase one. The trailer would cost approximately \$18,000 and the used truck would

cost about \$15,000-\$20,000 which would be covered by the fixed asset account in next year's budget. A driver policy for the trailer/truck combo can be worked out to the Board's satisfaction. He said it would also be safer by eliminating the risk of injury because it is low to the ground. Mr. Meachem asked if Mr. Miller's proposal that he brought forward is actually a cost savings. Mr. Miller said that the amount that was budgeted was \$25,000. Mr. Searfoss asked the amount for the trailer and the truck. Mr. Miller said it is about \$15,000-\$20,000 for a used trailer. Mr. Searfoss said the South Band parents bought a box truck which was a cost savings way to go and there were no injuries. Mr. Gress asked if the money is budgeted in next year's budget. Mrs. Bader said there is \$25,000 in large fixed asset account for a box truck. Mr. Gress cautioned purchasing a used vehicle because a brand new one may be the cost of a used one. He said this item can be looked into since safety is an issue and the last thing the district needs is someone getting hurt.

- L. Ms. Tomara Ellis asked if the removal of the teacher on special assignment for East Stroudsburg Elementary School was addressed. Mr. Meachem said that as of the last budget meeting, it was still included as an item to cut. He said he has done some research and understands the dynamic of the program and the reason why there is a need for a teacher on special assignment. He will make an appeal at the appropriate time to his colleagues and hopes, in addition to all tax considerations, that they find a way to keep this position. Ms. Ellis believes it would be irresponsible and an injustice to the children by eliminating this position. Mr. Bradley said this is something they are looking into and will take into consideration.
- M. Ms. Kerrie Curtis said she participated in many activities while she was in school. Over the summer she has paid a lot of money for her child to participate in activities. She said \$100 for every activity is cheaper than paying for activities over the summer. She suggested giving scholarships anonymously to those that cannot afford it and said fundraising may need to be stepped up.
- N. Ms. Frank Lupin asked the Board not to implement the activity fee. He said the \$130,000 that we may get from the activity fee will dwindle to less because many will not be able to afford to pay it. By the district's figures 50% are free or reduced or partially subsidized for lunch, so if they cannot afford to pay for lunch, how will they pay to participate. He asked not to balance the budget on the backs of the students and suggested taking the money out of the fund balance.
- O. Ms. Tanya Miller said people are living paycheck to paycheck and have financial hardships. She asked if the \$100 for athletic fee is per year. Mrs. Laverdure said it is for any activity they do per year. Ms. Miller said if they have multiple kids. It will be extra money they don't have and some kids need these for scholarships to get them to the next level. She suggested taking it from the slush fund. She said many don't come to meetings because the Board doesn't listen, so she asked them to listen and do what's best for the kids and their families.
- P. Mr. Timothy Vogt said he's had discussions with his neighbors about taxes, activity fees, etc. and they did not know how much money we had in the bank. He said we have \$35 million available to do something positive with. Avoiding a tax increase is absolutely the right thing to do. Why has no one mentioned a tax decrease because we would still be able to afford it with the fund balance? He said the activity fee that is being imposed is less than .4% of the fund balance that will affect all these parents and kids that may or may not be able to participate. To vote for an activity fee is irresponsible.
- Q. Ms. Diane Hinson asked if there is any reason why they do not have Board meetings at J. T. Lambert Intermediate School anymore. Mr. Gress said that the main reason is that a Board meeting room was built at the administration center for this specific reason and it was costly. Ms. Hinson suggested for next year having the meetings half way like at Middle Smithfield Elementary School.
- R. Mr. Mathew Ingram said that he is here representing the High School North Student Government as well as all students from the district. He said adding a fee to participate would cause devastation to their grades. Some who cannot afford to pay to participate will have grades suffer, since being part of some activities you need to have a grade of a 70. If they don't have that specific activity to look forward, to they will not care. It will also cause AYP scores to suffer because students will be discouraged and not try to do better. It will cause a bad reaction to the schools, district and State.
- S. Ms. Chieyen Meachem said she finds it ridiculous when a Board member says that they should not have a Board meeting up North because people will not come out or because of inclement weather. This is not an excuse not to have meeting at the North site because she does not have a choice not to go to school even if the roads are not all plowed.
