IX. SUPERINTENDENT'S REPORT

A. Mrs. Sharon Laverdure informed everyone that the district will operate on a two-hour delay tomorrow. The Connect Ed call will go out at 7:30 p.m. She advised the Board members and the Administrators to silence their cell phones.

- B. Mr. Roy Horton said that at the Monroe Career & Technical Institute (MCTI) meeting they spoke about the feasibility of someday turning the MCTI into a four year high school, which they believe would be more beneficial. At their next meeting, they will elect a committee to work on this movement. They also spoke about ways of how to attract more students and inform parents about MCTI since it's been said that this is "the best kept secret in Monroe County". They are also working on the budget and there's a slight increase. The ESASD share would be about -8.87% with the new formula. The majority of the budget will be paid by Stroudsburg Area School District because of the calculations with the new formula. Mr. Robert Cooke said that he had a meeting with Rep. Mario Scavello and they spoke about getting a grant for a new water tower and wondered if they had an update on it. Mr. Gary Summers said they spoke about it at the meeting and there was a motion on the table in November to get some money for it. They spoke about hooking up into the water from Rt. 611. They also spoke about applying for a grant for the water tower. Mr. Horton said that Rep. Scavello intended to go to the MCTI meeting but could not make it. Mr. Robert Gress said that the November money that was on the table is our money that we had submitted when we paid our share of the budget all these past years. He asked the committee members to bring this issue for discussion at the next meeting. They kept the money for PSERS but this money should be given back to us for our Fund Balance. Mr. Summers said that he spoke to Mr. Lazarchak, MCTI Director, and was told that this item should be placed back on the next agenda. Mrs. Laverdure said that because of the hard work of the past JOC Committee Members, they will get this money back. She thanked Mr. Cooke, Mr. Horton and Mr. Gress for being a part of this formula change.
- C. Ms. Eileen Featherman said that she distributed the Colonial IU 20 Newsletter. At the IU 20, they are at a stalemate with the support staff and professional staff negotiations. They will discuss how to proceed at the next meeting. Dr. Brennan will present the IU 20 budget soon at one of the upcoming Board meetings.
- D. Mr. Summers said that the MCTI will probably present their budget in March or April. Mrs. Laverdure said we typically schedule the IU 20 and MCTI budget presentations at different Board meetings.
- E. Mr. Robert Cooke said that the previously approved minutes of the Property/Facilities Committee meeting have been made available to the Board members and the public. The next meeting will be on February 6, 2014 in the Administration Center Board Room.
- F. Mr. Robert Gress said that the Finance Committee met on January 13, 2014 and the previously approved meeting minutes have been made available for the Board member and public. The next meeting will be on February 10, 2014 at 5:30 p.m. in the Administration Center Board Room. There are many items from the meeting on the agenda. One issue they are looking at is the tax rate for the upcoming budget since they are looking for a zero increase. Due to the inequalities and it's been a long time since they have reassessed, if we do a zero percent tax increase, common level ratio for Pike County and Monroe County will not be equal. Since a reassessment has not been done for a while, Monroe County will not see an increase but Pike County will see a decrease. Mr. Bader will see what can be done. We are moving forward with the budget process. The preliminary budget can only be increased by 2.3% but hopefully the State will give us more money to cut down on our expenses.
- G. Mrs. Laverdure thanked Mrs. Padavano, Bushkill Elementary Principal, for the video she presented. Mrs. Padavano said that in November, Bushkill Elementary spoke about giving thanks. All students wrote what they were thankful for. High School North students filmed the Bushkill Elementary students and they had a parade with the High School North Band.
- H. Mrs. Marjorie James said there was no Policy Review Committee in January but they are looking forward to continuing the discussion of the Dress Code Policy. The next meeting will be on February 24, 2014 at 5 p.m. Mr. Gress asked if anyone has a question on any policy should they give it to the Policy Review Committee Chair or should they attend the next meeting. Mrs. Laverdure said you can forward any policy discussion items to her and she will give it to the committee members. Mr. Searfoss suggested that they get the policy requests ahead of time in order to place them on the agenda for discussion.
- I. Mrs. Laverdure welcomed Dr. Lesniewski, Assistant Superintendent for Curriculum & Instruction Grades 6-12, on his first day on the job.
- J. Mr. Jeffrey Bader presented Draft #1 of the 2014-15 Budget process. He explained the handout which included revenues (local 71%, State 25%, Federal 1.8% and other 2.4%). Local revenues include real estate taxes, assessed value, collection rate and millage rates. He explained that county-wide reassessments have not been done in Monroe County since 1989 and in Pike County since 1994 which has contributed to commercial property owners getting assessment reductions and placing more of the tax burden on residential property owners. We are looking at a zero percent tax increase. Local Revenues are anticipated to be about 103 million dollars for the

2014-2015 school year. The State revenue includes subsidies, grants, mandated reimbursement, etc. at a total of about 36.5 million dollars. The federal revenue includes grants and other funding sources which total about 3.4 million dollars. The revenue total is about 146.1 million dollars based on a zero tax increase. This is a 2.23% increase from the 2013-14 budget. 1.7 million dollars is from the State Retirement Subsidy. He explained expenses which include wages & benefits, debt service, variable costs, etc. Some items the district has little control over are Wages & Benefits, PSERS, Health Insurance, Workers' Comp, Cyber/Charter School Tuition, etc. Some expense cost savings are due to utilities energy savings and IU Special Ed Services due to providing services in-house. Total expenses estimated for 2014-15 is approximately 154 million dollars. He explained a graph detailing the percentage of each expense that the district incurs. Direct Instruction of Students is 53.5%, Instructional Support is 9.7% and Transportation is 8.3%. The 2014-15 school year budget has about 46 million dollars in revenues, which is about 3.2 million dollars above this year's budget. The expenses are about 155 million dollars, which is about 7 million dollars above this year's budget. Overall it leaves about an 8.9 million dollar deficit because of the expenses exceeding the revenues. The Board allocated 5 million dollars from the fund balance to the general budget to cover this year's deficit; therefore, the 3 million plus the 5 million dollars equals the 2014-15 school year budget deficit of about 8 million dollars. He explained the millage impacts. East Stroudsburg Area School District is a multi-county school district; Pike County and Monroe County. Under the School Code the district has to balance its tax levy in the same proportion as the relative market values as established by the State Tax Equalization Board (STEB). Market values have been declining in both Monroe and Pike Counties but more rapidly in Pike than Monroe. What this means is that for every \$1 tax levied, a greater portion must be collected from Monroe County residents than in the prior year. With no tax increase, keeping the current tax levy means 188.82 mills for Monroe County which is a 4.4% increase and 128.94 mills for Pike County which is a 0% increase. We cannot do this scenario because it is above the allowed index. If we hold Monroe County millage the same then it would be 180.83 mills for Monroe County which is 0.01% increase and 123.48 mills for Pike County which is 4.2% decrease. This would bring the budget deficit from approximately 8.8 million dollars to 12.8 million dollars. We will continue to review all possibilities and balance the budget the best possible way.

Mr. Gress suggested to everyone that when they see their Representatives and Senators, they should let them know that our fund balance has been reserved for retirement expenses that we are mandated to pay. We received less money from the State than in previous years. We should let them know that the State should fund us adequately. We also have a bus expense of about one million dollars this year due to extending the bus-buy cycle to another year. He suggested looking at the appeal for 10 by 10 sheds that are part of the county and are taxable. If people start appealing paying taxes on them then it's less money that the district will get. He thanked Mr. Bader for his presentation and will continue, along with the Finance Committee, to look at decreasing expenditures

Mr. Summers asked when do we have to approve a final budget. Mr. Bader said no later than June 30th. Mr. Summers said we have five months to work our magic and keep taxes where they are. Mr. Bader said it is a daily activity.

Mrs. Laverdure thanked Mr. Bader for his presentation and for the time and effort he put into preparing it.

A. Mr. Frank Johnson asked since the collection rate is low, how do we improve this. Do we just cover their expenses if they do not pay? Mr. Bader said if the taxes are not paid they are turned over the Tax Claim Bureau as delinquent. Mr. Johnson asked if the tax collection increased 2011/12 due to foreclosures. Mr. Bader said this was due to the back pay of an assessment appeal. It was a one-time catch up but we won't see it again. The Tax Claim Bureau threatened to put names in the paper of those that were delinquent; therefore, some people paid up. Mr. Johnson asked if there is any outside agency that the district can contract to get our taxes. Mr. Bader said he believes that the district previously did this and it did not work out. It is better that the Tax Claim Bureau does it. We offer a program for taxpayers to pay their taxes in installments or they have the option to pay in full which gives them a discount. We have done a number of things to boost collection. Mr. Johnson said it just seems that some pay while others don't and those who pay pick up the burden while everyone gets the same service. Mr. Bader said we do our best with collection and we put out a lot of notices. Mr. Johnson asked if East Stroudsburg Area School District is the lowest in tax collection. Mr. Bader said he is not sure but we are probably among the lowest. Mr. Bader said that his budget presentation will be placed on the district website.
