ADOPTION OF PLANNED INSTRUCTION</p> <p>The Board shall provide a comprehensive program of planned instruction to enable school district students to <del>strive-achieve for</del> educational goals and attain academic standards <u>required for student achievement</u>.</p> <p>Planned instruction shall consist of at least the following:</p> <ol style="list-style-type: none"> <li>1. Objectives to be achieved by all students.</li> <li>2. Content, including suggested materials, activities and instructional time.</li> <li>3. Relationship between objectives of a planned course and the established academic standards.</li> <li>4. Procedure for measurement of <u>attainment of the</u> objectives <u>and academic standards</u>.</li> </ol> <p>No planned instruction shall be taught in school district schools unless it has been adopted by a majority vote of the full Board. The Board reserves the right to determine which units of the instructional program constitute such planned instruction and are subject to adoption by the Board.</p> <p>The Superintendent is responsible for the continuous evaluation of the <del>efficacy of courses of study</del> <u>effectiveness of the district's planned instruction</u> and shall recommend to the Board such new <del>courses of study as s/he</del> <u>and altered planned instruction</u> deemed <u>s</u> to be in the best interests of the students of this school district.</p> <p><del>S/He</del> <u>The Superintendent</u> shall invite the participation of <u>administrative and</u> professional staff members at every level in the school district in the formulation of <u>his/her</u> recommendations.</p> <p>The Superintendent shall maintain a current list of all planned <del>courses</del> <u>instruction</u> offered by this school district and shall furnish each member of the Board with a</p>
