VIII. SUPERINTENDENT'S REPORT

- A. Mr. Gress said that at the Monroe Career & Technical Institute meeting the support contract was approved. The MCTI budget was passed by all districts. The Cosmetology Program is being reviewed. The waterline issue is being worked on with PPL with regard to a Right of Way issue.
- B. Mrs. Featherman said that at the Colonial IU 20 meeting they were informed that they are working on the plans for the summer program. They were also informed that Kathy Emeigh, Director of Curriculum Services is retiring.
- C. Mr. Horton said that at the Property/Facilities Committee meeting they received an update from Ms. Gail Kulick on the Resica Community Playground. They also met with a representative, Mr. Sterling Colburn, from Trane to discuss their contract for services. They spoke about scrapping five district maintenance vehicles that have not been running and will get some funds from Harry You Pull It for them. Mr. Josh Grice was at the meeting regarding the asphalt phasing at the North Campus. Mr. Grice also reviewed an infrared moisture survey to check for possible leaks.

All policies have been revised to get them aligned with the Child Protective Services law.

The committee will continue to discuss Policy 707 – Use of Facilities to get more information to see what other districts are doing. They will also be discussing Policy #915 Booster Clubs/Parent Organizations.

- E. Mr. Robert Gress said that the Finance Committee meeting met on May 11th. There are about ten items on the agenda that were discussed at the meeting. The biggest item is the proposed final budget for next year. Mr. Bader will discuss this item as well as the Governor's budget later on tonight. The Board should be receiving a copy of the cumulative lost taxes from assessment appeals. Over the last five years, the district has lost about \$12,762,000. That's the reason he votes against tax appeals. When we look at the shortfalls from revenues and expenses it is the result of reassessments. The legislators should be looking into this. Tonight there are three on the agenda which will probably amount to \$50,000. This cannot be made up. He has been speaking about this issue for over ten years. The Board is asking to meet with the Pocono Record to explain the numbers and this issue of the lost assessments dollars that the district will continue to lose. The last reassessment was over 30 years ago. Mrs. Laverdure will be setting up a meeting with the Pocono Record to discuss this issue. We had a meeting with the Legislators and all but one Representative attended. Another item on the agenda is the LERTA item from Lehman Township. The Township set aside some properties and the ordinance will be equivalent to Middle Smithfield Township.
- F. Mr. Ronald Bradley reported that at the 2015 NSBA Conference that he attended in Nashville, TN, he was angry because of what he found out in terms of what we don't know and what we don't utilize. We don't know what is available to us. He spoke to Board Directors, Superintendents and Principals. The consensus is that educators need more training in digital learning and administrators need to know what the objectives are and how professional development can meet these goals. Minority males with disabilities are at the highest risk of dropping out. Disabilities are students who cannot read with limited English proficiency. There are a number of organizations that we have not been privy to including the National Black Council of School Board members, National Caucus of American Indian, Alaska Native School Board Members and National Hispanic Council of School Board Members. All of who, if we have been utilizing them, would have put us in better standing. We are behind the times in terms of what is available to us. We need a National Grant Program Department. We

need a fully functioning and running Human Resources Department. We are lacking in community outreach. We don't reach out to retired personnel, especially teachers, to get their input and help within the district. We don't have as much communication between administration, teachers and Board members as we should. We need more Board meetings because other counties have about 4 a month and we struggle with 1. There is a definite need for infrastructure improvement which is the reason that Lehman Township is here to present tonight. Other Boards across the country are aware of who we are and they say that we are basically living in a cocoon. In terms of grant programs State and Nationally, we are not taking advantage of nor are we involved with a lot of the grant programs available to us which will help us tremendously. They range from private to corporate as well as nonprofit organizations. The bottom line is we are out of touch and way behind. The most important item is that we don't have community involvement or support. Mr. Gress asked for a written report from Mr. Bradley. He said he is going to take exception to many points but would like to see it in writing first. Mrs. Laverdure thanked Mr. Bradley for his report. She said, as Superintendent, she believes that she has failed to make the Board aware of many items that Mr. Bradley has concerns with. When we receive Mr. Bradley's report, she will show you that we are involved with the community in many ways. She will explain all the different areas we are involved with. There is a presentation by students tonight and they will share how involved we are. Mr. Bradley said that the most important issue is that the community needs to get involved.

G. Miss Maya Henry, H.S. North Student Board Representative said that recently they had Kassandra Patrick (10th grader), who was selected to participate in a week long educational session at Cornell University in their Catalyst Academy which supports pursuits in the engineering fields. She also congratulated Anthony Cruz, Ryan Cruz, As-Sata Hall and Taylor Runo who qualified to compete in the PA Track and Field event at Shippensburg University. North completed its third Red Cross Blood Drive on May 8th in memory of Briana Bunyan. The drive was open to the staff, students and community. It generated 150 units of blood. Women's Resources met and presented to all 9th grade students on the topic of bullying and teen dating. H.S. North received a 2nd year bronze award from the US News and World Report as one of the Best High Schools in the United States. North held chorus and band concerts where students performed very well. They appreciate the Board member's support in music and arts. North held their 2nd Annual Run for the Red Event. Although they did not meet their goal, they came out strong and everyone had a good time. They are preparing for the installation of the North turf field with a start date scheduled for next week. She thanked the Board members and the community for their support.

Miss Nadia Hussein, H.S. South Student Board Representative, said that the Seniors had a great time at their Prom on May 9th at the Mayfaire Farm. They are currently in the middle of Keystone exams and still have two days left of testing. They are currently selecting class officers this week. H.S. South had a Casual for a Cause day for local Veterans and raised \$507. This Friday they will hold a Casual for a Cause day for the homeless. The UN Aspire Group led by Anish Bhagwat held a fundraiser called "The Initiative", which raised \$475 for children in need in India. We had two students Stephanie Sezon and Kelsey Picchianti attended a State-wide conference regarding issues of world peace and global issues. The Sports Marketing class is holding a block party on May 28th which is open to the community. A new LED sign is up and running donated by NEPA Federal Credit Union. High School South was awarded one of the best American High Schools named by US News and World Report for the third year in a row. Nadia introduced the Youth Voice Club which is making a report from the Youth Leadership Conference they attended in November.

H. Miss Nadia Hussein said the Youth Voice of High School South group attended a conference entitled, "Youth Today, Leaders Tomorrow" on November 15, 2014. The event was planned by high school students with the support of Youth Infusion and the Cavalier Justice Academy H.S. South and feedback from the Monroe County Council on Inclusion (MCCI). The Council, a volunteer organization, convened the youth conference as follow up to its successful Unity Seminar 2012 – an event that also resulted in recommendations for improving the quality of life for Monroe County residents. Youth Conference panel discussions explored issues of concern to youth in Monroe County, PA and recommended actions to meet challenges in topics of: Education, Youth Employment, Community Involvement, Health and Wellness and Diversity. They are here today to present the recommendations that were formulated at this conference and encourage the Board to take them into consideration for the future.

Education

Miss Michelle Mbuthia spoke about the education discussion which included questions such as What do you think makes up a perfect education? What is the weakest area of your education, etc? Miss Lauryn Antoine said three elements emerged that the students felt comprised a perfect education: 1. Teacher-student interactions. 2. Allowing students to explore possible career paths. 3. Increased socialization and peer interaction. Students felt that too much emphasis is placed on testing throughout the year. Michelle and Lauryn explained some areas for

consideration such as: provide strong funding to arts, female sports, electives, etc., administer tests later in the year, measure knowledge through essay tests and not allow test scores alone to determine student's ability to graduate.

Youth Employment

Miss Mikayla Longdon said the group answered the following questions: Who has or previously had a job? How did you receive the job? How could they improve jobs? Etc., etc. Their observations were: most jobs held by students were home based, volunteer work seemed to provide the main contribution to employment experience and jobs and volunteer opportunities were found through family, friends or through networking. Some areas for consideration were: provide more resources to get a job, organize youth career/job fair, create a school website to lists jobs, and provide more volunteering opportunities in the community.

Community Involvement

Miss Alexis Gonzalez said the group answered the following questions: What does community involvement look like to you? Do you know how to get involved in your community? Do you know what opportunities are available for community involvement? Etc., etc. Miss Caitlyn Stout said that some of their observations were: students thought that volunteering at different organizations provide a good opportunity. Some organizations they were involved in were Pocono Medical Center, YMCA and AWSOM. Alexis and Katie said some areas for consideration were: provide more opportunities for students in cyber school to get involved in the community, provide more clubs and resources in schools, provide easier access through public transportation, increase advertisement through social media, radio, flyers and commercials.

Health and Wellness

Miss Raemi Alexander said the group answered the following questions: What is your definition of being healthy? What problems get in the way of being healthy? Are drugs, alcohol and/or tobacco a problem in your school? Etc., etc. Some of their observations were: students believed that in order to be healthy, they have to be physically healthy, eat a balanced diet, etc. Participants believe that one cannot be fully healthy if they were not mentally healthy. Mental illness and depression were discussed as a threatening factor to health. Some areas for consideration were: provide more funding toward healthy lunches, offer opportunities and resources at school to help people who are addicted to substances, make fitness classes available, physical education for homeschooled students, etc.

Diversity

Miss Nadia Hussein said the group answered the following questions: When you hear diversity, what do you think of first? What do you consider as diverse? Do you think diversity is important? Some of their observations were: students need to take an active role in changing attitudes about diversity for the next generation and modeling behavior for the older generation. Some areas for consideration were: provide more education starting at a young age about differences, eliminate classes that divide students according to skill levels, provide community programs for people to meet and overcome differences, etc.

Alexis thanked the Board for allowing them some time to listen to their recommendations and hopes they take these into consideration when making future policies and decisions. By doing so, they can help improve the school communities through the various areas mentioned today.

Honorable John Siptroth, Monroe County Council on Inclusion, said that it's been about a year that they came before the Board to discuss the summary of the 2012 Conference. He thanked the School Board members and Superintendent for allowing the young adults to present the results of the conference. He wished more adults had the opportunity to be there. The young adults did a terrific job in putting it together and when participating in it. He said on behalf of the Co-chair Nitza Desire and co-founder Dagmaris Cabezas he thanked everyone for what the School Board has done. He thanked Bob Gress for being part of the Council. He also thanked Mrs. Patricia Tiernan, educator of High School South and Mr. Silvoy for his help. He hopes he can present the students' work to other School Boards since they have not been very receptive. The last page of the handout has all members and sponsors and any information they may need.

Mr. Gress thanked Honorable Siptroth and the Council members. East Stroudsburg Area School District (ESASD) is who other school districts should be mirroring. In the monthly meetings that are held by the Council, they always ask what are schools doing and they always mention that ESASD is involved in many activities. The Superintendent and teachers such as Patricia Tiernan are always involved. This is not always evident but he appreciates their participation. We will not cut programs, afterschool activities, etc., because they are so important for the students when going to college or elsewhere. Mr. Catrillo and Mr. Zall, Principals, always look to provide programs for the students. We are providing opportunities to wonderful kids who will do wonderful

things. Mr. Gress said he heard a speech at a commencement that we collectively fouled things up and the students will now have to fix it. He encouraged the students to stay involve.

Mr. Horton thanked Maya Henry and Nadia Hussein, Student Board Representative, for their participation. There are many community outreach programs, such as the National Honor Society in North and South. We may not know all of them but we should never assume that they are not happening.

Mrs. Laverdure thanked Maya Henry for her participation as Student Board Representative and wished her success in her future endeavors since she will be graduating this year.

Mr. Summers asked if someone on the staff will be looking over the areas for consideration. Mrs. Laverdure said she will discuss these considerations at her Administrative Team Meeting during the summer. Mr. Summers asked if she will provide a report by September or October. Mrs. Laverdure said she may provide it sooner.

Mr. Jeffrey Bader said under Act 1of 2006, the Board has to adopt a proposed final budget before the end of May and a final budget by June 30. The agenda has a proposed final budget. The first draft of the budget showed anticipated revenues of 144 million dollars and anticipated expenses of about 155 million dollars with a deficit of 11.7 million dollars. The Finance Committee has been working on the budget. Tonight he will be presenting changes. On the revenue side, there is net decrease of about 47,000 dollars from the original estimate. On the expense side, there have been a number of adjustments, some favorable and some not favorable. The Administration has been reviewing staffing needs and has been able to recommend adjustments in the District's staffing. We have about 5.3 million dollars of expense reductions from the first budget that was presented. Some staff adjustments which lead to 1.6 million dollars in savings. In the Professional Staff there are 28.5 positions that do not need to be filled. These positions are primarily positions that are vacant, are from individuals who have resigned or retired, or are long term substitute positions. Professional or Temporary Professional employees whose positions might be reduced as a result of the staffing needs should have an opportunity to move into other positions that are opening up. We anticipate minimal need to furlough, if at all. Support staff adjustments have a total 6.6 positions. Over the last five years, the District's enrollment has gradually declined by 888 students giving us an opportunity to revisit staffing needs. The Administration will only fill positions, if needed, which leads to staff adjustments. The prior budget draft had an estimated deficit of 11.7 million dollars. These adjustments have reduced the deficit to 6.5 million dollars. Although significant progress has been made, more needs to be done. The Board has allocated about 2 million dollars of the fund balance that was earmarked for the PSERS retirement rate increase to cover the deficit. We will need to look again for continued reductions or the fund balance to balance the budget. The millage rates have decreased slightly. In Monroe, there is a decrease of 1.43% and Pike .01%. Because of the market value in two counties, we see a slight decrease in Pike County. This is the fourth consecutive year that the Board has not approved a tax increase. We will continue to review staffing needs. We should be able to reflect some adjustments as we go forward. We await the State Budget resolution. The Legislative Committee reviewing the Basic Ed Funding Formula had a meeting here in November where Mrs. Laverdure testified against inadequate funding. We are not clear what their recommendation will be. However, it is likely that any funding formula that they come up with will only be on new money. It will be up to the legislatures to supply new funding. We are waiting for final budget on Governor's/Legislative agreement. If we receive what is proposed, we will get about 2 million dollars.

Mr. Searfoss said the Finance Committee along with Jeff Baker worked hard on the budget. They took time to bring it down. He is very pleased. Mr. Gress said that down the road there are some issues that will need to be addressed. The funding formula is not changing. He will provide some comments when they discuss the proposed final budget. Mr. Bradley asked if he millage rate will drop for Monroe County like it did for Pike County last year. Mr. Bader said that there is a decrease for Monroe in next year's budget. Mr. Bradley asked how much is the decrease. Mr. Bader said that it depends on home's assessment. Mr. Gress said it can be from \$20 to \$60. Mr. Searfoss said he would have liked for the Pocono Record to place in tomorrow's paper that at ESASD the millage rate is lower than last year. The Pocono Record is not present at tonight's meeting

J. Mr. David Baker, Principal of Middle Smithfield Elementary, said at a recent literacy night, they met a young lady and asked her to present tonight before the School Board. She is a wonderful and incredible young author, Sarah Farah. Sarah said that she is the author of Snowy & Moey which she wrote when she was four years old and previously had it published. She never thought when she was sharing her story with her mom, it would get published and make her money, too. She advises all students that they can accomplish whatever they want. Every child has a spark of creativity in them. We would have a whole school of authors if they believe in themselves. It's not easy publishing a book but the staff from the district helped her in making her dream come true. She thanked everyone. She suggested everyone encourage at least one child to express who they are. Mrs. Laverdure said that Sarah and her parents are donating a display for the Middle Smithfield Elementary Library. Sarah

introduced her parents, Elena Farah and Hany Farah. Mrs. Laverdure wished her luck at her new school, since she will be moving on to 6th grade and said that the district will be purchasing her book to place in all elementary school libraries.

- K. Mrs. Laverdure thanked Mr. Paul Bakner and Mr. Zall because they had a very unique situation that occurred on Saturday night. They lost power due to a lightning storm that blew a transformer. They had scheduled a 15-year Alumni Band Concert. They had to move the band from the stage to the cafeteria which was not easy to do. I saw Mr. Bakner say we are going to do this and the students were cooperative because within ten minutes they were ready to begin in the cafeteria. They had probably one of the most fantastic concerts that they have ever had. This was thanks to the students, parents, administrators, custodial staff and security staff. Everyone pulled together to make this a special night. We have a great group of people at ESASD. There will be an announcement at the end of the Board meeting in order to deal with the transformer issue and be able to approve the repairs.

B. Proposed Taxes in Monroe County and in Pike County

ACTION BY THE BOARD:

Motion was made by Roy Horton to tentatively approve the tax rates listed below for the 2015-16 fiscal year. These rates represent a 1.43 mill decrease for Monroe County and a 0.01 mill decrease for Pike County. Motion was seconded by Eileen Featherman. A roll call vote was taken and carried unanimously, 9-0. Ronald Bradley, Robert Cooke, Eileen Featherman, Robert Gress, Roy Horton, Robert Huffman, Marjorie James, William Searfoss and Gary Summers voted yes.

a. Be it resolved that a tax of 179.38 mills be proposed on real estate in the Monroe County portion of the East Stroudsburg Area School District for the 2015-16 fiscal year; and

- b. Be it resolved that a tax of 123.44 mills be proposed on real estate in the Pike County portion of the East Stroudsburg Area School District for the 2015-16 fiscal year; and
- c. Be it resolved the 1% Earned Income Tax be proposed to remain in effect be placed on all residents of the District for the 2015-16 fiscal year, of which 0.5% is shared with local municipalities; and
- d. Be it resolved that the \$10.00 Occupational Privilege Tax be proposed to remain in effect to be placed on all workers in the District for the 2015-16 fiscal year; and
- e. Be it resolved that the 1% Real Estate Transfer Tax be proposed to remain in effect for the 2015-16 fiscal year, of which 0.5% is shared with the municipalities.

C. Summer Food Program

ACTION BY THE BOARD:

Motion was made by Roy Horton to approve the operation of the Seamless Summer Option Food Service Program at Bushkill Elementary School, East Stroudsburg Elementary School, J.M. Hill Elementary School, Middle Smithfield Elementary School, Resica Elementary School, Smithfield Elementary School, and Senior High School South from Monday, June 15, 2015 through approximately August 21, 2015. Programs will operate at various times and dates throughout the summer as determined by Administration. This program is funded through Federal and State reimbursements and is cost neutral to the district. Motion was seconded by Robert Huffman and carried unanimously, 9-0.

D. Public Hearing-LERTA

ACTION BY THE BOARD:

Motion was seconded by Eileen Featherman and carried unanimously, 9-0.

Mr. Dirvonas said the district received quotes for bids pursuant to the emergency provisions of the School Code. Before we can proceed, there are some questions with regards to the quotes and the District needs some time to review them to make sure they are all meeting the required specifications. We are not in a position to make or award the bid to any of the three bidders tonight. We need more time to review and to hold another meeting to award a bid. The Board members can meet sometime next week. The proposals were reviewed by Sharon Laverdure, Jeff Bader, Dan Eppley and himself (Tom Dirvonas), and they do not feel comfortable making a decision tonight.

Ms. Michal Peterson asked if the Board is in a position to give out the bid information. Mr. Dirvonas said they are not. Ms. Peterson asked how is this expense going to be paid. Mr. Dirvonas said the insurance will pay for it. Mr. Bader said it is subject to a deductible. Mr. Dirvonas said that it will not cost the taxpayer any money.

Mr. Dymond asked if an architect or engineer will look at it to make sure it is the right transformer, wiring, etc. Mr. Bader asked if he means the transformer that is being looked at. Mr. Dymond said yes. Mr. Bader said that when the building was originally built, the transformer was specified to meet the needs of the building by the engineer. Mr. Dymond asked if they need to update because it may be overloaded. Mr. Bader said overloading is not the issue. The transformer was struck by lightning. Mr. Dymond asked why was it just this one that was affected. Mr. Bader said it was the only one hit by lightning. Mr. Zall said it caught on fire. Mr. Summer reiterated that the transformer was hit by lightning.

Mr. Dirvonas said that the Board needs to decide on a date to reconvene the meeting and suggested not earlier than Thursday, May 28th in order for Strunk Albert Engineering to review the proposals in order to compare the quotes and gather a list of questions.

Ms. Peterson asked if Strunk Albert Engineering will be charging a fee to do this since it must not be difficult to prepare bids. This may be a \$10,000 expense to the district. Mr. Bader said it will not be. Mr. Dirvonas said that he would suggest that the insurance company bear this expense.

Mr. Bradley said that we should choose another engineering firm because he does not agree with Strunk Albert Engineering. Mr. Dirvonas said that is up to the Board to decide how much time they want to take to make the decision. Mr. Bradley said that the Board needs to look at someone else. Mr. Bader said we have dealt with Strunk Albert Engineering and D'Huy Engineering but it may take weeks before D'Huy can come to the district to review proposals. Mr. Bradley said we should use D'Huy Engineering.

Mr. Gress said that we should have someone that knows our schools. Mr. Bradley said D'Huy Engineering knows the District because Strunk Albert Engineering is not the only one in this town. Mr. Gress said Strunk Albert Engineering is a local firm.

Ms. Peterson asked if the specs are on line. Mr. Dirvonas said they are not. Ms. Peterson asked if the insurance will cover the cost of all bids. Mr. Dirvonas said they will. Mr. Gress suggested that we include the cost for all personnel fees who have been involved with this issue. We should pick a firm that knows our property and will help us make the right decision to get it done right.

Mr. Gress asked what was the deductible. Mr. Bader said it is about \$2,500 or \$5,000 depending on whether coverage is under the property policy or the equipment breakdown policy.

Mr. Dymond asked who is the original engineer for the school because he does not believe that Strunk Albert Engineering has experience with big schools. Mrs. Laverdure said they are currently helping to build a large school.

Mr. Dirvonas said that, in summary, this was an "act of God" that took out the transformer. We need to replace it as soon as possible.

Mr. Dirvonas asked which Board members are available to attend the reconvened meeting on Thursday, May 28th at 7:00 p.m.

Mr. Cooke, Mr. Gress, Mr. Huffman, Mr. Summers, Mr. Bradley and Ms. Featherman said they can. Mr. Horton said he cannot due to a work conflict.

Mr. Bradley said he would like a layman's breakdown of the items that will be replaced. Mr. Summers said this is what Strunk Albert Engineering will be supplying.

 - A. Ms. Michal Peterson asked since the request for bids was not advertised, what was the process the district took to obtain bids, how many were received and from who. Mr. Bader said the District followed the emergency purchasing procedures as contained in the School Code and obtained three quotes. The district received a quote from Wind Gap Electric Inc., who was present at the site when the power shut off. The district also received quotes from Ace Electric, Inc. and George Hayden Electric Communication. Wind Gap Electric Inc. provided the lowest bid. The district made sure that the contracts were comparable. All three firms were on site to view situation. Ms. Peterson asked how quickly will they fix the situation since the emergency generator already shut down/failed for a day. Mr. Bader said the emergency generator was fixed by the next morning. Mrs. Laverdure said the emergency generator was actually fixed by 8:00 p.m. of the same day that it shut down. Mr. Bader said that once they order the new transformer, it will take 3-5 days to deliver. If the Board approves the bid proposal tonight, the order will be placed tomorrow. They plan to come into the North Campus next Friday and work on it over the weekend. The proposal included premium time for the work to be done over the weekend. It will take about three days to replace the transformer and get everything connected. They should have the transformer up and running by Monday morning. Mrs. Peterson asked if they are purchasing the same transformer we had or was it upgraded. Mr. Bader said it has the same specifications. Mr. Eppley said there's a lot of work to be done. It involves a high voltage, pulling all new primary and secondary circuits, making all new connectors, etc. The old transformer needs to be pulled out by a crane and the new one set in place. It will be tight to get it done by Monday. Mrs. Laverdure asked if the emergency generator will remain connected until the new transformer in connected. Mr. Eppley said the emergency generator will be fully operational until all the work is done.

XXXI. FISCAL ITEM

ACTION BY THE BOARD:

Motion was made by Eileen Featherman to accept the bid proposal of Wind Gap Electric, Inc. in the amount of \$192,670.00 to provide labor and materials to replace an existing pad mount transformer and related equipment, apparatus and wiring at High School North. The contract amount includes prevailing wages but excludes bonding costs as well as electrical permits and inspections, to the extent they are necessary. This action is being taken pursuant to the emergency provisions of Section 751 (a.2) of the School Code [24 PS 7-751 (a.2)]. Motion was seconded by Gary Summers and carried unanimously, 5-0.

Mr. Summers asked what are they replacing the transformer with. Is it identical to the one we have? Is it new or refurbished? Mr. Eppley said it is an identical refurbished transformer. Mr. Summers asked if we know the age of when they refurbished the equipment. Mr. Eppley said we do not have that information but the refurbished transformer comes with a two to three year warranty. Mr. Summers said that he searched refurbished transformers and he found that they cost about \$13,000-\$40,000; therefore, he hopes we are getting a good price for it. Mr. Gress asked if the district will pay for the replacement and then receive reimbursement from the insurance company. Mr. Bader said that is correct. Mr. Gress said we need a backup plan in case the work is not completed in time. Mr. Bader said the emergency generator will still be operational. Mrs. Laverdure said that we will not put students in a building that is not operational, even if it means we have to close. Mr. Eppley said that if we call tomorrow, we need to make sure we get all materials that will be needed for next weekend. Mr. Summers asked if we can delay the installation until school is out to avoid any risk. Mr. Eppley said as it is he's been holding his breath because we are operating on 12 wires compared to the normal 36 wires. Mr. Gress said whatever we decide to do, we need an alternate plan in case something happens. Mr. Eppley said he will stay in contact with them to make sure that they have everything that they will need.

Mr. Searfoss asked if there will be a point of when they start and cannot stop. Mr. Eppley said that they can check with them on Sunday to see if they will be finished and, if need be, the emergency generator can be turned on. Mr. Searfoss said so there is no point that they can say we cannot function. Mr. Eppley said he does not think that it works that way. They know how to space out the work.

Mr. Summers said he is concerned with reporting to the insurance company what Wind Gap Electric reported that the damage appears to be as a result of the transformer being struck by lightning. Mr. Eppley said that he was called to the North campus because a transformer was on fire. Officer Gangaware reported that lightning bolts were hitting all over. Mr. Brown said that the insurance company went to the site and confirmed that the transformer was hit by lightning.
