Policy #'s 105.2, 110, 112, 119, 125, 126, and 130, 204.2 have been revised to align with current PA School Code and include minor changes in language and/or movement of items to mirror PSBA recommendations.

Policy #111 Lesson Plans is updated to include that teachers shall prepare lesson plans in either written form or electronically and lists audiovisual resources rather than listing items separately that change with time and advances

in technology. Discussion included the number of days lesson plans must be prepared in advance. Mrs. Laverdure suggested that three (3) days in advance is reasonable and aligns with the district's requirement for a doctor's note for all absences in excess of three days for staff. The committee members agreed. The draft policy will be updated to reflect this change.

Policy #118 Independent Study is updated to include language that the Building Principal must approve each student's request for a course of independent study and that independent study shall be limited to credit classes needed for graduation.

Policy #120 Human Development Program is proposed for REPEAL as it is embedded within Curriculum Development which requires Board approval and, therefore, is redundant.

Policy #146 Student Services is revised as a result of a recent mandate that districts must provide a Student Assistant Program in all district buildings.
