Jeff,

As per our discussion, we would like to ask the boards permission to go out bid for wireless infrastructure for JTL and Lehman Intermediate Schools so we can seek eRate reimbursement on the equipment we will be buying. Our discount level is 80%, meaning the district would be responsible for 20% of the total cost of the eRate eligible items.

REASON: Looking to improve and handle the increased load of the wireless network at each school which has an access point in every other classroom as well as the common areas by replacing the current access points, and installing additional AP's so there is one in every classroom, as well as additional coverage in common areas. The current AP's were bought in 2011 and are nearing the end of their lifecycle.

This past year, we went out to bid for core network infrastructure items for our north and south data centers, as well as wireless infrastructure at both high schools (Year 1). Next year (16-17) we intend to do the two intermediates, and the following year (17-18), the six elementary schools.

Equipment items we are seeking for JTL and LIS are as follows:

- Approximately 92 AP's for JTL (currently 40)
- Approximately 77 AP's for LIS (currently 33)
- Nine, 48 port switches to power the AP's JTL (5) and LIS (4)
- Nine UPS' (Uninterruptible Power Supply's) replace what is currently there.

Based on bids we received in the past, and equipment costs from PEPPM, I am ball parking the costs as follows:

- AP's 169 x \$750 = \$126.750
- Switches 9 x \$4,000 = \$36,000
- UPS 9 x \$1,600 = \$14,400
- TOTAL ESTIMATED COST \$177,150
- TOTAL Estimated eRate Reimbursement = \$141,720
- TOTAL Estimated District Cost = \$35,430
- NOTE These are all approximations, but are fairly close to where I see these items coming in at. I
 am hopeful they are a bit lower.

LICENSE AGREEMENT

WITNESSETH

In consideration of the mutual covenants contained herein and intending to be legally bound hereby, the Parties hereto agree as follows:

- 1. PREMISES. Licensor hereby licenses to Licensee approximately Forty-Two (42) square feet of space on the ground (the "Ground Space) and space upon an existing light pole (the "Tower Space") located at The East Stroudsburg Area High School, 279 North Courtland Street, East Stroudsburg, Monroe County, Pennsylvania 18301 (the entirety of such real property being referred to as the "Property"), for the installation, operation and maintenance of communications equipment; together with such additional space on the Property for the installation, operation and maintenance of antennas (the "Antenna Space"); together with such additional space on the Property for the installation, operation and maintenance of wires, cables, conduits, brackets and pipes (the "Cabling Space") running between and among the Ground Space, Tower Space and Antenna Space and to all necessary electrical and telephone utility sources located on the Property; together with the non-exclusive right of ingress and egress from a public right-of-way, seven (7) days a week, twenty four (24) hours a day, over the Property to and from the Premises (as hereinafter defined) for the purpose of installation, operation and maintenance of Licensee's communications facility. The Ground Space, Tower Space, Antenna Space and Cabling Space are hereinafter collectively referred to as the "Premises" and are as shown on Exhibit "A" attached hereto and made a part hereof. In the event there are not sufficient electric and telephone, cable or fiber utility sources located on the Property, Licensor agrees to grant Licensee or the local utility provider the right to install such utilities on, over and/or under the Property necessary for Licensee to operate its communications facility, provided the location of such utilities shall be as reasonably designated by Licensor.
- 2. <u>CONDITION OF PROPERTY</u>. At the Commencement Date (as hereafter defined), the Premises shall be in its current condition free of debris. Licensor represents and warrants to

Licensee that as of the Effective Date and continuing throughout the Term (as hereinafter defined): (a) the Premises is in compliance with all Laws (as defined in Paragraph 24 below), including any applicable building codes, regulations, or ordinances which may exist with regard to the Premises, or any part thereof; and (b) the Premises is free of all lead-based paint, asbestos or other hazardous substances, as such term may be defined under any applicable federal, state or local law. If a breach of the representations and warranties contained in this Paragraph 2 is discovered at any time during the Term, Licensor shall, promptly after receipt of written notice from Licensee setting forth a description of such non-compliance, rectify same at Licensor's expense.

3. TERM; LICENSE FEES.

This Agreement shall be effective as of the date of execution by both Parties (the "Effective Date"), provided, however, the initial term shall be for five (5) years and shall commence on the first day of the month following the day that Licensee commences installation of the equipment on the Premises (the "Commencement Date") at which time license fee payments shall commence and be due at a total annual amount of Four Thousand Eight Hundred and 00/100 Dollars (\$4,800.00) to be paid in advance annually on the Commencement Date and on each anniversary of it in advance, to Licensor or to such other person, firm or place as Licensor may, from time to time, designate in writing at least thirty (30) days in advance of any license fee payment date by notice given in accordance with Paragraph 18 below. Licensor and Licensee acknowledge and agree that initial license fee payments shall not actually be sent by Licensee until thirty (30) days after the Commencement Date. Licensor and Licensee agree that they shall acknowledge in writing the Commencement Date.

Upon agreement of the Parties, Licensee may pay license fees by electronic funds transfer and in such event, Licensor agrees to provide to Licensee bank routing information for such purpose upon request of Licensee.

Licensor hereby agrees to provide to Licensee certain documentation (the "License Documentation") including without limitation: (i) documentation evidencing Licensor's good and sufficient title to and/or interest in the Property and right to receive license fee payments and other benefits hereunder; (ii) a completed Internal Revenue Service Form W-9, or equivalent for any party to whom license fee payments are to be made pursuant to this Agreement; and (iii) other documentation reasonably requested by Licensee and within fifteen (15) days of obtaining an interest in the Property or this Agreement, any assignee(s), transferee(s) or other successor(s) in interest of Licensor shall provide to Licensee such License Fee Documentation. All documentation shall be acceptable to Licensee in Licensee's reasonable discretion. Delivery of License Fee Documentation to Licensee shall be a prerequisite for the payment of any license fees by Licensee and notwithstanding anything to the contrary herein, Licensee shall have no obligation to make any license fee payments until License Fee Documentation has been supplied to Licensee as provided herein.

Within thirty (30) days of a written request from Licensee, Licensor or any assignee(s) or transferee(s) of Licensor agrees to provide updated License Fee Documentation. Delivery of License Fee Documentation to Licensee shall be a prerequisite for the payment of any license fees by Licensee to such party and notwithstanding anything to the contrary herein, Licensee shall have no obligation to make any license fee payments until License Documentation has been supplied to Licensee as provided herein.

4. <u>ELECTRICAL</u>. Licensor shall, at all times during the Term, make electrical service and telephone service available at the Property. Licensee shall furnish and install an electrical meter at the Premises for the measurement of electrical power used by Licensee's installation. The Licensee shall pay the utility directly for its power and/or telephone service consumption.

Licensee shall be permitted at any time during the Term, to install, maintain and/or provide access to and use of, as necessary (during any power interruption at the Premises), a temporary power source, and all related equipment and appurtenances within the Premises, or elsewhere on the Property in such locations as reasonably approved by Licensor. Licensee shall have the right to install conduits connecting the temporary power source and related appurtenances to the Premises in such locations as are mutually acceptable to Licensor and to Licensee.

- 5. <u>EXTENSIONS</u>. This Agreement shall automatically be extended for four (4) additional five (5) year terms unless Licensee terminates it at the end of the then current term by giving Licensor written notice of the intent to terminate at least three (3) months prior to the end of the then current term. The initial term and all extensions shall be collectively referred to herein as the "Term".
- 6. <u>LICENSE FEE ESCALATION</u>. Upon each anniversary of the Commencement Date, the annual license fee paid by Licensee to Licensor shall be increased by an amount equal to two percent (2%) over the annual license fee paid by Licensee to Licensor during the immediately preceding year.
- 7. <u>USE; GOVERNMENTAL APPROVALS</u>. Licensee shall use the Premises for the purpose of constructing, maintaining, repairing and operating a communications facility and uses incidental thereto. Licensee shall have the right to replace, repair, add or otherwise modify its utilities, equipment, antennas and/or conduits or any portion thereof and the frequencies over which the equipment operates, whether the equipment, antennas, conduits or frequencies are specified or not on any exhibit attached hereto, during the Term. It is understood and agreed that Licensee's ability to use the Premises is contingent upon its obtaining after the execution date of this Agreement all of the certificates, permits and other approvals (collectively the "Governmental Approvals") that may be required by any Federal, State or Local authorities as well as a satisfactory building structural analysis which will permit Licensee use of the Premises as set forth above. Licensor shall cooperate with Licensee in its effort to obtain such approvals and shall take no action which would adversely affect the status of the Property with respect to the proposed use thereof by Licensee. In the event

that (i) any of such applications for such Governmental Approvals should be finally rejected; (ii) any Governmental Approval issued to Licensee is canceled, expires, lapses, or is otherwise withdrawn or terminated by governmental authority; and (iii) Licensee determines that such Governmental Approvals may not be obtained in a timely manner, Licensee shall have the right to terminate this Agreement. Notice of Licensee's exercise of its right to terminate shall be given to Licensor in accordance with the notice provisions set forth in Paragraph 18 and shall be effective upon the mailing of such notice by Licensee, or upon such later date as designated by Licensee. All license fees paid to said termination date shall be retained by Licensor. Upon such termination, this Agreement shall be of no further force or effect except to the extent of the representations, warranties and indemnities made by each Party to the other hereunder. Otherwise, the Licensee shall have no further obligations for the payment of license fees to Licensor.

8. <u>INDEMNIFICATION</u>. Subject to Paragraph 9, below, Licensee shall indemnify and hold Licensor harmless against any claim of liability or loss from personal injury or property damage resulting from or arising out of the negligence or willful misconduct of Licensee, its employees, contractors or agents, except to the extent such claims or damages may be due to or caused by the negligence or willful misconduct of Licensor, or its employees, contractors or agents.

9. INSURANCE.

- a. The Parties hereby waive and release any and all rights of action for negligence against the other which may hereafter arise on account of damage to the Premises or to the Property, resulting from any fire, or other casualty of the kind covered by standard fire insurance policies with extended coverage, regardless of whether or not, or in what amounts, such insurance is now or hereafter carried by the Parties, or either of them. These waivers and releases shall apply between the Parties and they shall also apply to any claims under or through either Party as a result of any asserted right of subrogation. All such policies of insurance obtained by either Party concerning the Premises or the Property shall waive the insurer's right of subrogation against the other Party.
- b. Licensee agrees that it will obtain the following insurance coverage at its sole cost and expense:

Workers Compensation - Statutory coverage and amounts as required by state law, with Employer's Liability limits of:

\$500,000 Each Accident \$500,000 Aggregate for Injury by Disease \$500,000 Each Employee for Injury by Disease

Policy shall include waiver of subrogation in favor of Licensor, if allowable by state law.

Commercial General Liability - Including Premises Operations. Products/Completed Operations, Contractual Liability and Personal and Advertising Injury.

Bodily Injury and Property Damage Combined Single Limit:

\$1,000,000 Any One Occurrence

\$1,000,000 Personal and Advertising Injury

\$1,000,000 Products/Completed Operations Aggregate

\$2,000,000 General Aggregate

\$50,000 Fire Damage Liability

\$5,000 Medical Expense - Each Person

General Liability insurance shall be written on an "occurrence" form and shall include Licensor as Additional Insured as its interests may appear under this Agreement excluding Workers Compensation and Employers Liability on a primary and non-contributory basis. A blanket additional insured endorsement shall be attached to the Certificate of Insurance.

Commercial Automobile Liability - Including coverage for owned, hired, leased and non-owned vehicles.

Bodily Injury and Property Damage \$1,000,000 Combined Single Limit Each Accident

- c. Licensor agrees that at its own cost and expense, it will maintain commercial general liability insurance with limits not less than \$1,000,000 for injury to or death of one or more persons in any one occurrence and \$500,000 for damage or destruction to property in any one occurrence. Licensor agrees that it will include Licensee as an additional insured.
- 10. <u>LIMITATION OF LIABILITY</u>. Except for indemnification pursuant to Paragraphs 8 and 22, neither Party shall be liable to the other, or any of their respective agents, representatives, employees for any lost revenue, lost profits, loss of technology, rights or services, incidental, punitive, indirect, special or consequential damages, loss of data, or interruption or loss of use of service, even if advised of the possibility of such damages, whether under theory of contract, tort (including negligence), strict liability or otherwise.
- 11. <u>ANNUAL TERMINATION</u>. Notwithstanding anything to the contrary contained herein, provided Licensee is not in default hereunder beyond applicable notice and cure periods, Licensee shall have the right to terminate this Agreement upon the annual anniversary of the Commencement Date provided that three (3) months prior notice is given to Licensor.
- 12. <u>INTERFERENCE</u>. Licensee agrees to install equipment of the type and frequency which will not cause harmful interference which is measurable in accordance with then existing

industry standards to any equipment of Licensor or other Licensees of the Property which existed on the Property prior to the date this Agreement is executed by the Parties. In the event any after-installed Licensee's equipment causes such interference, and after Licensor has notified Licensee in writing of such interference, Licensee will take all reasonable steps necessary to correct and eliminate the interference within ninety (90) days, including but not limited to, at Licensee's option, powering down such equipment and later powering up such equipment for intermittent testing. Licensor acknowledges that interference may come from different sources, and Licensee shall only be responsible to correct interference caused by Licensee's equipment. In the event Licensee fails to so correct such interference after said notice and time period, Licensee shall be in default under this Agreement. Licensor agrees that Licensor and/or any other tenants of the Property who currently have or in the future take possession of the Property will be permitted to install only such equipment that is the type and frequency which will not cause harmful interference which is measurable in accordance with the then existing industry standards to the then existing equipment of Licensee. The Parties acknowledge that there will not be an adequate remedy at law for noncompliance with the provisions of this Paragraph and therefore, either Party shall have the right to equitable remedies, such as, without limitation, injunctive relief and specific performance.

- 13. REMOVAL AT END OF TERM. Licensee shall, upon expiration of the Term, or within ninety (90) days after any earlier termination of the Agreement, remove its equipment, conduits, fixtures and all personal property and restore the Premises to its original condition, reasonable wear and tear and casualty damage not caused by Licensee excepted. Licensor agrees and acknowledges that all of the equipment, conduits, fixtures and personal property of Licensee shall remain the personal property of Licensee and Licensee shall have the right to remove the same at any time during the Term, whether or not said items are considered fixtures and attachments to real property under applicable laws. If such time for removal causes Licensee to remain on the Premises after termination of this Agreement, Licensee shall pay license fees at the then existing monthly rate or on the existing monthly pro-rata basis if based upon a longer payment term, until such time as the removal of the equipment, antenna structure, fixtures and all personal property are completed.
- 14. <u>RIGHT OF FIRST REFUSAL (COMMUNICATIONS EASEMENT)</u>. If Licensor elects, during the Term to grant to a third party by easement or other legal instrument an interest in and to that portion of the Premises and/or Property occupied by Licensee, or a larger portion thereof, for the purpose of operating and maintaining communications facilities or the management thereof, with or without an assignment of this Agreement to such third party, Licensee shall have the right of first refusal to meet any bona fide offer of transfer on the same terms and conditions of such offer. If Licensee fails to meet such bona fide offer within thirty (30) days after written notice thereof from Licensor, Licensor may grant the easement or interest in the Premises, Property or portion thereof to such third person in accordance with the terms and conditions of such third party offer.
- 15. <u>RIGHTS UPON SALE</u>. Should Licensor, at any time during the Term decide (i) to sell or transfer all or any part of the Property or the Premises to a purchaser other than Licensee, or (ii) to grant to a third party by easement or other legal instrument an interest in and to that portion of

the Premises and or Property occupied by Licensee, or a larger portion thereof, for the purpose of operating and maintaining communications facilities or the management thereof, such sale or grant of an easement or interest therein shall be under and subject to this Agreement and any such purchaser or transferee shall recognize Licensee's rights hereunder under the terms of this Agreement. In the event that Licensor completes any such sale, transfer, or grant described in this paragraph without executing an assignment of this Agreement whereby the third party agrees in writing to assume all obligations of Licensor under this Agreement, then Licensor shall not be released from its obligations to Licensee under this Agreement, and Licensee shall have the right to look to Licensor and the third party for the full performance of this Agreement.

- 16. QUIET ENJOYMENT AND REPRESENTATIONS. Licensor covenants that Licensee, on paying the license fees and performing the covenants herein, shall peaceably and quietly have, hold and enjoy the Premises. Licensor represents and warrants to Licensee as of the execution date of this Agreement, and covenants during the Term that Licensor is seized of good and sufficient title and interest to the Property and has full authority to enter into and execute this Agreement. Licensor further covenants during the Term that there are no liens, judgments or impediments of title on the Premises, or affecting Licensor's title to the same and that there are no covenants, easements or restrictions which prevent or adversely affect the use or occupancy of the Premises by Licensee as set forth above.
- ASSIGNMENT. This Agreement may be sold, assigned or transferred by the Licensee without any approval or consent of the Licensor to the Licensee's principal, affiliates, subsidiaries of its principal or to any entity which acquires all or substantially all of Licensee's assets in the market defined by the Federal Communications Commission in which the Property is located by reason of a merger, acquisition or other business reorganization. As to other parties, this Agreement may not be sold, assigned or transferred without the written consent of the Licensor, which such consent will not be unreasonably withheld, delayed or conditioned. No change of stock ownership, partnership interest or control of Licensee or transfer upon partnership or corporate dissolution of Licensee shall constitute an assignment hereunder.
- 18. <u>NOTICES</u>. All notices hereunder must be in writing and shall be deemed validly given if sent by certified mail, return receipt requested or by commercial courier, provided the courier's regular business is delivery service and provided further that it guarantees delivery to the addressee by the end of the next business day following the courier's receipt from the sender, addressed as follows (or any other address that the Party to be notified may have designated to the sender by like notice):

Notice shall be effective upon actual receipt or refusal as shown on the receipt obtained pursuant to the foregoing.

- 19. <u>RECORDING</u>. Licensor agrees to execute a Memorandum of this Agreement which Licensee may record with the appropriate recording officer. The date set forth in the Memorandum of Lease is for recording purposes only and bears no reference to commencement of either the Term or license fee payments.
- 20. DEFAULT. In the event there is a breach by a Party with respect to any of the provisions of this Agreement or its obligations under it, the non-breaching Party shall give the breaching Party written notice of such breach. After receipt of such written notice, the breaching Party shall have thirty (30) days in which to cure any breach, provided the breaching Party shall have such extended period as may be required beyond the thirty (30) days if the breaching Party commences the cure within the thirty (30) day period and thereafter continuously and diligently pursues the cure to completion. The non-breaching Party may not maintain any action or effect any remedies for default against the breaching Party unless and until the breaching Party has failed to cure the breach within the time periods provided in this Paragraph. Notwithstanding the foregoing to the contrary, it shall be a default under this Agreement if Licensor fails, within five (5) days after receipt of written notice of such breach, to perform an obligation required to be performed by Licensor if the failure to perform such an obligation interferes with Licensee's ability to conduct its business at the Premises; provided, however, that if the nature of Licensor's obligation is such that more than five (5) days after such notice is reasonably required for its performance, then it shall not be a default under this Agreement if performance is commenced within such five (5) day period and thereafter diligently pursued to completion.
- 21. <u>REMEDIES</u>. In the event of a default by either Party with respect to a material provision of this Agreement, without limiting the non-defaulting Party in the exercise of any right or remedy which the non-defaulting Party may have by reason of such default, the non-defaulting Party may terminate the Agreement and/or pursue any remedy now or hereafter available to the non-defaulting Party under the Laws or judicial decisions of the state in which the Premises are located. Further, upon a default, the non-defaulting Party may at its option (but without obligation to

do so), perform the defaulting Party's duty or obligation on the defaulting Party's behalf, including but not limited to the obtaining of reasonably required insurance policies.

22. ENVIRONMENTAL.

- a. Licensor will be responsible for all obligations of compliance with any and all environmental and industrial hygiene laws, including any regulations, guidelines, standards, or policies of any governmental authorities regulating or imposing standards of liability or standards of conduct with regard to any environmental or industrial hygiene conditions or concerns as may now or at any time hereafter be in effect, that are or were in any way related to activity now conducted in, on, or in any way related to the Premises or Property, unless such conditions or concerns are caused by the specific activities of Licensee in the Premises.
- b. Licensor shall hold Licensee harmless and indemnify Licensee from and assume all duties, responsibility and liability at Licensor's sole cost and expense, for all duties, responsibilities, and liability (for payment of penalties, sanctions, forfeitures, losses, costs, or damages) and for responding to any action, notice, claim, order, summons, citation, directive, litigation, investigation or proceeding which is in any way related to: a) failure to comply with any environmental or industrial hygiene law, including without limitation any regulations, guidelines, standards, or policies of any governmental authorities regulating or imposing standards of liability or standards of conduct with regard to any environmental or industrial hygiene concerns or conditions as may now or at any time hereafter be in effect, unless such non-compliance results from conditions caused by Licensee; and b) any environmental or industrial hygiene conditions arising out of or in any way related to the condition of the Premises or Property or activities conducted thereon, unless such environmental conditions are caused by Licensee.
- c. Licensee shall hold Licensor harmless and indemnify Licensor from and assume all duties, responsibility and liability at Licensee's sole cost and expense, for all duties, responsibilities, and liability (for payment of penalties, sanctions, forfeitures, losses, costs, or damages) and for responding to any action, notice, claim, order, summons, citation, directive, litigation, investigation or proceeding which is in any way related to: a) failure to comply with any environmental or industrial hygiene law, including without limitation any regulations, guidelines, standards, or policies of any governmental authorities regulating or imposing standards of liability or standards of conduct with regard to any environmental or industrial hygiene concerns or conditions as may now or at any time hereafter be in effect, to the extent that such non-compliance results from conditions caused by Licensee; and b) any environmental or industrial hygiene conditions arising out of or in any way related to the condition of the Premises or Property or activities conducted thereon, to the extent that such environmental conditions are caused by Licensee.
- 23. <u>CASUALTY</u>. In the event of damage by fire or other casualty to the Property or Premises not caused by LICENSEE that cannot reasonably be expected to be repaired within forty-five (45) days following same or, if the Property is damaged by fire or other casualty so that

such damage may reasonably be expected to disrupt Licensee's operations at the Premises for more than forty-five (45) days, then Licensee may, at any time following such fire or other casualty, provided Licensor has not completed the restoration required to permit Licensee to resume its operation at the Premises, terminate this Agreement upon fifteen (15) days prior written notice to Licensor. Any such notice of termination shall cause this Agreement to expire with the same force and effect as though the date set forth in such notice were the date originally set as the expiration date of this Agreement and the Parties shall make an appropriate adjustment, as of such termination date, with respect to payments due to the other under this Agreement. Notwithstanding the foregoing, the license fees shall abate during the period of repair following such fire or other casualty in proportion to the degree to which Licensee's use of the Premises is impaired.

- 24. <u>APPLICABLE LAWS</u>. During the Term, Licensor shall maintain the Property and all structural elements of the Premises in compliance with all applicable laws, rules, regulations, ordinances, directives, covenants, easements, zoning and land use regulations, and restrictions of record, permits, building codes, and the requirements of any applicable fire insurance underwriter or rating bureau, now in effect or which may hereafter come into effect (including, without limitation, the Americans with Disabilities Act and laws regulating hazardous substances) (collectively "Laws"). Licensee shall, in respect to the condition of the Premises and at Licensee's sole cost and expense, comply with (a) all Laws relating solely to Licensee's specific and unique nature of use of the Premises; and (b) all building codes requiring modifications to the Premises due to the improvements being made by Licensee in the Premises.
- 25. <u>EFFECT OF LICENSE</u>. This Agreement can only be terminated in accordance with the terms set forth in it or as a remedy for a default which is not cured within the time and in the manner provided herein.
- 26. MISCELLANEOUS. This Agreement contains all agreements, promises and understandings between the Licensor and the Licensee regarding this transaction, and no oral agreement, promises or understandings shall be binding upon either the Licensor or the Licensee in any dispute, controversy or proceeding. This Agreement may not be amended or varied except in a writing signed by all parties. This Agreement shall extend to and bind the heirs, personal representatives, successors and assigns hereto. The failure of either party to insist upon strict performance of any of the terms or conditions of this Agreement or to exercise any of its rights hereunder shall not waive such rights and such party shall have the right to enforce such rights at any time. This Agreement and the performance thereof shall be governed interpreted, construed and regulated by the laws of the state in which the Premises is located without reference to its choice of law rules.

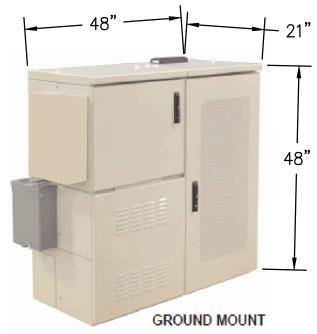

RESOLUTION

WHEREAS, on June 27, 2006, the Pennsylvania legislature passed Act 1 of Special Session 2006, known as the "Taxpayer Relief Act" (hereinafter "Act 1");

WHEREAS, Act 1 requires school districts to limit tax increases to the level set by the index, as defined by Act 1, unless the tax increase is approved by voters in a referendum or the school district obtains from the Department of Education or a court of common pleas certain referendum exceptions;

WHEREAS, Act allows a board of school directors to elect to adopt a resolution indicating that it will not raise the rate of any tax for the support of the public schools for the following fiscal year by more than the index, provided this resolution must be adopted no later than 110 days prior to the date of the election immediately preceding the upcoming fiscal year;

WHEREAS, the East Stroudsburg Area School District index for the 2016-2017 fiscal year is 3.3% as calculated by the Department of Education;

WHEREAS, the East Stroudsburg Area School District Board of Education wishes to express its intention that it shall not raise the real estate property tax rate for the support of the East Stroudsburg Area School District for the 2016-2017 fiscal year by more than the index.

WHEREAS, this Resolution does not require that the East Stroudsburg Area School District Board of School Directors raise the real estate property tax rate for the 2016-17 fiscal year.

AND NOW, on this 21st day of December, 2015, it is hereby RESOLVED by the East Stroudsburg Area School District (hereinafter "District") Board of Education (hereinafter "Board") the following:

- 1. The Board certifies that it will not increase any school district tax for the 2016-2017 school year at a rate that exceeds the index as calculated by the Department of Education.
- 2. The Board certifies that it will comply with the procedures set forth in Section 687, of the Pennsylvania Public School Code (hereinafter "School Code"), 24 P.S. §6-687, for the adoption of the District's proposed and final budget.
- 3. The Board certifies that increasing any tax at a rate less than or equal to the index will be sufficient to balance its final budget of the 2016-2017 fiscal year.

- 4. The Administration of the District is directed to submit the District's information on a proposed increase in the rate of a tax levied for the support of the District to the Pennsylvania Department of Education on the uniform form prepared by the Pennsylvania Department of Education no later than five days after the Board's adoption of this Resolution.
- 5. The Administration of the District is directed to send a copy of this Resolution to the Pennsylvania Department of Education no later than five days after the Board's adoption of this Resolution.
- 6. The Board understands and agrees that by passing this Resolution it is not eligible to seek referendum exceptions under Section 333(f) of Act 1 and is not eligible to request approval from the voters through a referendum to increase a tax rate by more than the index as established for the 2016-2017 fiscal year.
- 7. Once this Resolution is passed, the Administration of the District is not required to comply with the preliminary budget requirements set forth in paragraphs (a) and (c) of Section 311 of Act 1. Provided, however:
 - (a) The Board understands and agrees that, upon receipt of the information submitted by the District as set forth in paragraphs 4 and 5 above, the Pennsylvania Department of Education shall compare the District's proposed percentage increase in the rate of the tax with the index.
 - (b) Within ten days of the receipt of this information, the Pennsylvania Department of Education shall inform the District whether its proposed tax rate increase is less than or equal to the index.
 - (c) If the Pennsylvania Department of Education determines that the District's proposed increase in the rate of the District's tax exceeds the index, the District is subject to the preliminary budget requirements as set forth in paragraph (a) and (c) of Section 311 of Act 1.

Dear Mr. Bader,

The Board of Supervisors received your letter dated June 25, 2015 requesting a change in sewer fees for Middle Smithfield and Resica Elementary Schools. Your letter stated that you believe that the schools should be charged at the rate for a school with a cafeteria but no gym or showers.

Upon discussion with our Engineer it has been decided that Middle Smithfield Elementary is in the right category of 1 EDU per 22 persons because it has a gym. The EDU schedule states an educational institution with a cafeteria, gymnasium and showers but that does not mean only a gym with showers. The clarification of this is a gym with or without showers. Middle Smithfield Elementary has a gymnasium but no showers and therefore should be in this category.

It has been decided that Resica Elementary will be categorized in the category for institutions with a cafeteria but no gym or shower at 1 EDU per 26 persons. While you have a room you use as a gymnasium with basketball hoops and a climbing wall, it is actually a multipurpose room used as a cafeteria and auditorium as well.

As for the number of individuals used by the Township to calculate the EDUs, I received an email from the East Stroudsburg Area School District last year with the numbers when we changed the EDU schedule. The School District is encouraged to send new attendance numbers at the beginning of each school year. If a change is warranted based on the new numbers we will make the change. I will use your updated numbers to recalculate the fees.

With the new numbers and the categories set, the new quarterly bills will be as follows:
