East Stroudsburg Area School District Property & Facilities - NorthSite Pneumatics Discussion

July 2, 2018

The Trane Team has been asked by the District to attend the Property & Facilities Committee Meeting on July 5th for an open discussion about the existing condition of the pneumatic controls system at NorthSite. The following is some of the background about the controls.

The building control system is the foundation of the mechanical systems for a facility. It drives energy usage, occupant comfort and overall operational efficiency of a building.

North High School, Lehman Intermediate and Bushkill Elementary are the only schools within the District, which have not been converted to digital controls.

Current concerns about the existing pneumatic system

- Water and oil have accumulated over time
- All of the end devices are failing
 - ✓ Diaphragms in the relays are deteriorating because of the water and oil
 - ✓ The relay bodies and transducer interiors are rusting
 - ✓ The deterioration causes air leaks throughout the building
- Tubing is wet and oily throughout the facility in certain areas water squirts out of the tubing when removed
- Air compressor
 - ✓ Runs constantly due to the leaks
 - ✓ Has developed a leak in the compressor head
 - ✓ Air dryer is ineffective
- Damage to the system is already done and cannot be reversed
- Pneumatic parts pricing has quadrupled over the last 3-4 years
- Existing controllers are obsolete

What this means to the District

- ✓ Do not provide the control opportunities of digital systems
- ✓ Wastes substantial energy
- ✓ Are difficult and expensive to repair and continuing to get worse
- ✓ Maintenance intensive
- ✓ Overall technical expertise in the industry is limited Colleges and technical schools do not teach these systems any longer




Updated digital controls will provide:

- 1. Improved comfort and educational environment
- 2. Energy savings
- 3. Enhanced facilities staff productivity
 - ✓ Remote access
 - ✓ Ability to resolve operational problems quickly
 - ✓ Systems alarms identifies systems and/or component failures
- 4. Wireless network easier to operate...requires less infrastructure
- 5. Enhanced zoning/scheduling capabilities. Individual classrooms/spaces can be scheduled.
- 6. Higher level control strategies, such as demand control ventilation. This only provides outdoor air ventilation when the room is occupied by students/teachers.
- 7. Reduced maintenance cost parts and labor
- 8. Documentation of system performance through trending. This can be beneficial in dealing with teacher grievances
- 9. Replacement of obsolete controls equipment
- 10. Building optimization
- 11. North High School and Lehman Intermediate will be current with the other buildings in the District
