V. ANNOUNCEMENT OF EXECUTIVE SESSION(S)

a. An executive session was held this evening at 5:30 p.m. before this meeting for the purpose of discussing personnel, litigation and negotiations.

VI. ADOPTION OF AGENDA

ACTION BY THE BOARD:

Motion was made by Lisa VanWhy to adopt the agenda for July 16, 2018, as submitted, with the Board of Education reserving the right to add to the agenda, and take further action on any items raised in executive session where immediate action on such items is considered to be in the best interest of the District. Motion was seconded by Debbie Kulick.

Motion was made by Lisa VanWhy to add to the agenda a motion to set a date to advertise a RFP to hire Special Construction Counsel. Motion was seconded by Wayne Rohner and carried unanimously, 8-0.

Motion was made by Richard Schlameuss to add to the agenda the rescission of Policy 221 that is scheduled to be implemented for the 2018-2019 school year and to revert to the current policy. Motion was seconded by Keith Karkut. A roll call vote was taken and motion failed 4-4. George Andrews, Keith Karkut, Richard Schlameuss, and Lisa VanWhy voted yes. Larry Dymond, Robert Huffman, Debbie Kulick and Wayne Rohner voted no.

Motion was made by Debbie Kulick to adopt the agenda with the amendment to set a date to advertise a RFP to hire Special Construction Counsel. Motion was seconded by Lisa VanWhy and passed, 7-1. Keith Karkut voted no.

VII. APPROVAL OF MINUTES

ACTION BY THE BOARD:

Motion was made by Debbie Kulick to approve the minutes of the June 18, 2018. Motion was seconded by Lisa VanWhy and carried unanimously, 8-0.

VIII. REPORTS

- Monroe Career & Technical Institute Update Mrs. Lisa VanWhy said there is nothing to report this evening.
- b. Colonial IU 20 Update Mr. Robert Huffman said the IU 20 does not meet during the summer; therefore, he does not have anything to report this evening.

c. Property/Facilities Committee Update

Mr. Wayne Rohner said that the Property/Facilities Committee met on July 5, 2018. The following items require Board action:

- 1. The proposal from Superheat for the repair and installation of a Well Mclain boiler for the domestic hot water tank in the amount of \$12,200 for Smithfield Elementary School.
- 2. The proposal from D'Huy Engineering to move forward with the North Campus survey and bid specification designs for the North roof repairs. He read the proposal and apparently the district has not been able to locate documentation on the roof manufacturer and warranty information for a school project built only18 years ago. This is an example of continued insubordination on the part of employees of the administration center.
- 3. To obtain additional quotes to get seal coating for the Administration and High School South parking lots because we only received one quote.
- 4. To obtain additional quotes for picking up falling paint chips off the cafeteria ceiling at H.S. North and Lehman Intermediate Schools. This is occurring most likely due to faulty construction work.
- d. Finance Committee Update

Mrs. Lisa VanWhy said the Finance Committee met on July 9th. The committee recommended that the Board exonerate the roll back taxes in the amount of \$518.21 for a piece of land that was sold to East Stroudsburg Borough. The land is part of the Clean and Green Program Property Act 319. The other items that were recommended for approval were the Property/Facilities Committee items and the payment of bills.

e. Policy Review Committee

Mr. Robert Huffman said the Policy Review Committee met earlier this evening and have recommended that administration post the following policies for public review during the month of July and subsequent Board action in August (pending final review by the district's legal counsel):

- f. Potential Board Vacancy

Mr. Thomas Dirvonas said that as all Board members are aware, they received a letter of resignation from Judy Summers due to their relocation to a senior residence in New Jersey to be closer to their daughter. Rather than take action on this matter tonight, he recommends referring it to the August meeting. The law is

that once a resignation is accepted by the Board, they would have to take action by August 16th, which is four days before our next scheduled meeting. This would require having to schedule a special meeting. Mr. Brown spoke to Mrs. Summers and she is in full agreement. Mr. Dirvonas said he would like to get direction from the Board on how they would like to advertise this resignation. He asked if they would like to accept Mrs. Summers resignation on August 20 and also fill the vacancy. The last time the Board had a vacancy, it was advertised and they asked for letters of interest from the public. He asked does the Board want to receive letters in advance and take action on August 20th or at the September meeting. Mrs. Kulick asked if the Board needs to make a motion. Mr. Dirvonas said he only needs direction from the Board in order to advertise the vacancy. It would make sense to ask for letters of interest by August 6^{th} . The Board will have about 2 weeks to review the letters. Mr. Karkut asked if the Board is going to vote at the August 20th meeting. Mrs. Kulick said the Board will accept Mrs. Summer's resignation on August 20th. Mr. Dirvonas said that they can also have the appointment in order not to have special meeting. Mr. Dirvonas said if there are no objections he we will advertise the vacancy. Mr. Dymond asked if it will be advertised and then the Board will take action on August 20th. Mr. Dirvonas said it will be advertised on the website. Mr. Karkut said, for the record, he will not be able to attend the August 20th Board meeting. He has a show that was booked before he was appointed on the Board. Mr. Karkut said, therefore, he will not be able to vote and only seven Board members will be voting. Mr. Schlameuss said this means there will not be a deadlock vote. Mr. Karkut asked if having the vote in August is a pressing issue. Mr. Dirvonas said Mrs. Summers agreed to wait until the August meeting.

IX. PUBLIC PARTICIPATION

Limited to comments on this agenda by residents and taxpayers of the school district (3 min. ea.)

- A. Mrs. Maria Hopkins said when they consider a new person to sit on the Board, that person needs to be considerate of the taxpayers, teachers, parents, students and especially agree to a fair teacher contract agreement. They also need to be empathetic of the families regarding the new dress code. She thanked Mrs. Summers for her work on the Board. Ms. Hopkins distributed a list of issues with the current dress code. She said she called all schools and got different answers on how the dress code is being interpreted.
- B. Ms. Laura Pride said she could speak about many items on the agenda such as why there is no teacher contract, the outrageous administrators' salaries, severe dress code, etc. What she will talk about is the Board's lack of respect for educators, support staff and the public at large. At last month's meeting, she spoke about what is fair and honorable and she doesn't see anything changing. If things do not get better, the public will vote the Board members out.
- C. Ms. Rebecca Bear said she has submitted her name for the Board vacancy. She does not know what to buy at the store to comply with the new dress code. Some clothing that are acceptable in the workplace are not part of the revised dress code. Not having a dress code will not make the students poor learners. Also there needs to be an agreement with the teachers. She does not want students staying home during the strike. We owe the students by letting them know how to dress, giving the teachers a fair contract and insuring they get an education.
- D. Ms. Jessica Faught said she is disgusted that the Board is speaking about seal coating and paint chips; meanwhile, the teachers do not have a contract. The teachers now have to deal with a new dress code and increase in the cost of living with no increase in salary. Teachers are important not the dress code. Performance will lack with no contract and with the revised dress code. Students should not miss out on education due to the possible strike.
- E. Mr. John Petrizzo asked permission to speak about an item that is not on the agenda. Mr. Huffman allowed him to speak. Mr. Petrizzo said he would like to speak about the tax abatement regarding the Gateway Project. He calls it failure number 4. The first one was when there was a tax transfer that the district did not get from the sale of 100 condos that were demolished and not rebuilt. The hotel was purchased by a church that will not pay taxes. The second tax abatement was the Mountain Laurel Center which still has 20 years of tax abatement and it sits there in ruins. The third tax abatement is the Delaware Water Gap National Recreation area with 77,000 acres of nothing. It is unconscionable for the district to consider giving away future money on the Gateway Project without having a contract for the teachers and support staff.

- F. Mr. James Laker said he agrees with what Mr. Petrizzo said. He suggested that the four Board members that are in favor of the dress code explain way they are for the dress code. It does not make sense. Many parents do not want it so why implement it. Also, the teachers need a contract.
- G. Ms. Dina McManus said the dress code does not allow for school pride or school spirit. The dress code is very vague and she does not know the answer to the many questions she's been asked about what to wear. She has invested a lot of money over the years and this wear has been allowed. She brought t-shirts, joggers, sweatshirts, etc. Many students are in sports, clubs, etc. Wearing these clothes will help them feel invested in their school. Students should be able to wear it. Many items that were purchased help support the student's teams and activities. She asked that the dress code allow school pride.
- H. Mr. Ruben Torres said that he is a single parent and if there is a strike in 55 days, this will impose child care issues for him. Many parents will also struggle with childcare issues. If teachers strike, he will stand with them along with his children. He suggested that the Board sit down with the teachers and come to a fair agreement now.
