Mr. Huffman said that the Board will schedule another date in order to discuss the TIF Plan. The meeting will be advertised and posted online.

g. Mr. Karkut said he would like to be added under reports. He thanked the Board for appointing him as the PSBA Liaison. He has nothing to report at this time.

IX. PUBLIC PARTICIPATION

Limited to comments on this agenda by residents and taxpayers of the school district (3 min. ea.)

Mr. Huffman said that the teachers passed the agreement, as it was presented last night. Four individuals from the Board were on the committee; therefore, the Board will possibly be passing it tonight since they only need one more member to vote in favor. In his opinion, there is no need to talk about the contract. He said Public Participation is being allowed at this time regarding the Professional Staff contract only.

- A. Mrs. Ann Catrillo, President of ESEA, said she is happy to report that, as Mr. Huffman announced, the Association has overwhelmingly accepted the tentative agreement. She thanked the Board Committee for their work, although they did not always agree within the past two years of negotiations. She understands they are volunteers; therefore, their time is appreciated. She thanked the community members, parents, and students for their support.
- B. Ms. Laura Pride said that no one will forget this past week. The ESASD experienced the first teacher strike. If the Board approves the agreement, some will be clapping because kids will be going back to school. As a community, they showed that everyone supported each other during a very difficult situation. As a community they should not see this as a terrible situation but the beginning of doing something in a different manner. Teachers spent their time providing community service and the community, parents, students supported the teachers. The Board has finally come to an agreement, due to the the response from the community. She thanked the Board for negotiating and hopes what happened does not repeat.
- C. Ms. Rebecca Bear thanked the Board for reaching an agreement. She said shame on everyone for allowing this to happen. They should have looked back seven years ago when the contract was frozen and the professional staff did not get a raise. There are also other issues like the dress code and facilities problems. The community's voices need to be heard as parents and taxpayers for the benefit of the children. She hopes this mutual understanding is not just for a short while but they should work together to make this a great place to live in.
- D. Mr. Ruben Torres said the Board has belittled the children and cause hardship on the parents by not settling a contract. The Board owes the community an apology. They treated people they were elected to serve as insignificant and bothersome. Some comments and gestures are uncalled for, offensive and unprofessional. If you don't apologize, then those who are responsible for their comments should resign. If they don't, the community will vote you out. The Board has failed the teachers, support staff, community, and students. They performed their duties unsatisfactorily.
- E. Mrs. Lee Ann Stokes said she remembers that when she was hired as a teacher the Superintendent said this school district is one with a heart. And it was. The last three years and especially last week she questioned if the district still has a heart since the district sat on a large fund balance. The heart lies with the teachers who picketed and do all they can for the students. The community realized it by their support. No new teacher would want to come into this district since they will receive the lowest pay; meanwhile, the district has the 3rd highest fund balance. If this district has a heart they would not have done what they did. They need to do what is best for the students.

- F. Ms. Kate Curry thanked the Board for their service. Teachers work above and beyond their scheduled hours. They work afterhours following up with parents, grading papers, and attending events. She thanked teachers for doing all they do. They could not get paid enough but the district should pay them more than they are getting now.
- G. Ms. Maria Hopkins said that teachers and parents banded together. She hopes the Board will show them how much they deserve by voting yes to the agreement.
- H. Ms. Darryl Sabino said that the Board is here to be the voice of the community and not do what they want. They should respect constitutional rights of the students. She is confident that tonight's vote will be unanimous in favor of the contract.
- I. Rep. Maureen Madden said she represents the people in this audience. She spent some time on the picket line and was moved by the outpouring of support from parents, students and community. When she is out at meetings talking about schools, she says the ESASD district has amongst the best teachers. She's been invited to H.S. South more than any other school. The Board needs to know they have amongst the best teachers in the schools. There are many programs in the district and the teachers turn out wonderful students. Teachers should be treated better. With reference to the Dress Code, there are no closets for the students who cannot afford to pay for what is required as part of the Dress Code. Some parents cannot afford clothes so how can they expect students to be prepared.
- J. Miss Jessika Gort said that students felt threatened by the Board and Administration. Band students were allowed to play at the football game after the many calls from the students and community. Why did the Board and Administration take the strike out on the students? They should not take things away from the students. She hopes this strike was an eye opener. Students are doing their best and do not appreciate having activities taken away from them. It's unfair and illogical.
