VIII. REPORTS

a. Monroe Career & Technical Institute Update

Mr. Larry Dymond said that at the JOC meeting they discussed the budget, which was presented to the Board at last month's Regular School Board meeting. The agenda was short and the other item of discussion was a personnel matter. Mrs. Lisa VanWhy said the MCTI's 2019-2020 budget and capital improvement budget is on the agenda tonight for the Board's consideration.

b. Colonial IU 20 Update

Mr. Robert Huffman said he could not attend the last IU 20 meeting but has the latest IU Newsletter available for any Board member who would like a copy.

c. Property/Facilities Committee Update

Mr. Wayne Rohner said the Property/Facilities Committee met on March 7th. Items requiring action were as follows:

- 1. Payment to D'Huy Engineering for invoice # 48874 for \$2,000 for their monthly retainer fee.
- 2. Payment to D'Huy Engineering for invoice #48878 in the amount of \$689.01 for services rendered from January 1 to January 25, 2019 for Trane's control oversight for the North campus. The contract amount for this project is \$26,255.00.
- 3. Payment to D'Huy Engineering for invoice #48879 in the amount of \$1,556.24 for the North campus water heater replacement.
- 4. Payment to D'Huy Engineering for invoice #48876 in the amount of \$7,793.98 for the Resica Elementary roof replacement.
- 5. Payment to D'Huy Engineering for invoice #48875 in the amount of \$38,129.94 for the North campus roof replacement project with respect to design, bidding and construction phase services.
- 6. The proposal from Integra One in the amount of \$64,953.00 for security cameras at the Resica Elementary School. The district is purchasing 51 Meraki cameras to replace the 18 Honeywell cameras which are currently at Resica as well as adding 33 cameras for increased security. An update was provided on the installation at Smithfield Elementary, TLC and Bus garage at J. T. Lambert Intermediate Schools. All of these areas were completed.
- 7. The proposal from Winter Engine for the purchase and installation of a new John Deere 445 HF motor for \$17,736.00 for the North campus bus garage generator. Mr. Karkut said the motion was for a brand new John Deere engine with a full John Deere warranty for delivery within 2-4 weeks as presented by Winter Engine. Mr. Rohner said the lead time delivery of this engine is 2-4 weeks.
- 8. The proposal from C & D Waterproofing Corp. in the amount of \$647,250.00 for Resica Elementary roof replacement, with Alternates 1 & 2 for a 30-year warranty and the infill of the existing sky light at an additional cost.
- 9. The proposal from Jottan, Inc. roofing for \$6,556.857.00 for the North Campus roof replacement project which includes an additional \$451,768.00 for a 30-year warranty. This roof has had multiple leaks since day one. It should be under a 25-year warranty. The North Campus is just 19 years old and no one in Administration knows where the warranty is. This is an example of collusion and corruption.
- 10. The proposal from Guyette Communication Industries Corp. for the North Campus Surveillance Camera Installation in the amount of \$342,736.00.

Also, D'Huy Engineering is coordinating with Trane for the bid results for the North Campus water heater replacement.

Mr. Rohner said that the district received a communication from the Department of Labor & Industry. It included a notice of violation for Middle Smithfield Elementary School. The school district along with the Middle Smithfield Township Board of Supervisors, Mitchell Marcus, Mark Dwyer and Annette Atkinson as well as the Solicitor violated the law as noted by the letter. The findings on the letter were multiple roof leaks throughout the building and mold was evident. He said that the notice dated February 11, 2019, stated that the findings from the Department of Labor & Industry were numerous roof leaks in 8 rooms, 2nd floor elevator lobby, gym rear entrance lobby and at the top and bottom of gym stair/ramp. Some leaks are significant and the school has placed buckets, trash cans and such to catch the water. The district has been tasked to:

1. Repair roof leaks, stop water infiltration, replace or repair drywall as needed in area of leaks and replace ceiling tiles as needed.

2. Contract with a certified independent agency to perform an air quality test throughout the building, which the district did a couple of months ago. Based on the findings of the test, report, complete an additional plan or remediation to comply with those findings. Upon completion of the plan of action, retest the areas in the building to assure that proper air quality is maintained. Reports of this inspection shall be provided to the Department of Labor and Industry for further review and action as

necessary by May 14th, 2019. There is an opportunity for a variance extension of time. Failure to comply may result in legal action and compromise the continued occupancy and use of this building. In summary, Mr. Rohner said the facts are he was a Building Code Official in Middle Smithfield Township (Township) during the construction of this addition. In 2012, he denied the building the Certificate of Occupancy. The pressure of school officials and guidance from the law firm, King Spry, which is a conflict of interest since they represented the school district since 2008 and then was appointed as the Solicitor for the Township in 2012, caused the Township to strip him of his title of Building Code Official in April 2012. He was told by the Township Supervisors that it was not due to his job performance but due to insurance reasons. According to Mitchell Marcus, the school district was threatening legal actions for his denial. In March or April of 2013, he, Wayne, denied the school district the zoning certificate of occupancy for not following the approved land development plan. By law, the school district had 30 days to appeal his denial of the Certificate of Occupancy, which they did. A public hearing with Zoning Hearing Board was scheduled for May 28, 2013. He was then ushered into an employment evaluation on Friday, May 10, 2013 and suspended without pay on May 14th and then terminated on May 23, 2013 for following the laws of the NPC to no avail. The public hearing was canceled. The Township issued a Certificate of Occupancy to the school district. The Supervisors violated their Oath of Office by breaking the laws of the Constitution of the State of PA. Their poor leadership is now costing the district millions of dollars due to all of the repairs that need to get done. Taxpayers should hold them all accountable for their irrational actions. Here we are with a notice of violation letter from the Dept. of Labor & Industry threatening legal action with a date of compliance of May 14th. They too, may revoke the Certificate of Occupancy for this school building. He is requesting that his report be entered into the minutes of this meeting. Mr. Rohner asked if there is any Board member who had an objection to his request. No one did. Mr. Karkut said he respects Mr. Rohner's report and believes it is factual. The only problem he has is that it was done under the committee report and not in another area. Mr. Rohner said that he thought it should be done under Property/Facilities Committee items, for transparency reasons, since there are media reports currently occurring. Mr. Karkut said there used to be an area on the agenda where Board members could speak but it was removed from the policy about half a year ago. Mrs. VanWhy said this should be relooked at so it can be added back on the agenda.

d. Finance Committee Update

Mr. Richard Schlameuss said the Finance Committee meeting met on March 11, 2019. Mr. Brown presented a draft of an Assessment Appeal Policy, which the Committee recommended it be forwarded to the Policy Review Committee. The Committee reviewed the Microsoft Agreement Renewal, which was presented by Mr. Borosh for the software products that are used in the district. The Committee heard a presentation regarding the School-Based ACCESS Program. Mr. McIntyre informed the Committee regarding the Auditor General Audit Report. A procurement manual discussion was held and more information will follow once the Committee irons out all details. Mr. McIntyre went over the budget transfers, payment of bills and treasury reports. Mr. McIntyre reviewed the whole process and will be explaining these items tonight.

The Committee recommended for approval all of the Property/Facilities items that Mr. Rohner mentioned minus the bus garage generator because it only had a 90-day warranty and not the full year. The Committee also recommended for approval the North roof, Resica roof and the North Campus security cameras as well as a Visitor Management System.

Mr. Schlameuss said the Board members received within their packets a Treasury Report, which Mr. McIntyre will explain tonight. Mr. McIntyre said the Board members received a document marked example and a treasury report. The example document has the numbers which match up with the treasury report. It indicates how each number comes directly from the bank statements. He went over and explained how they would find each section and each amount. The example document will help with each month's treasury report.

e. Policy Review Committee Update

Mr. Robert Huffman said that the Policy Review Committee meeting was cancelled for earlier this evening. However, at last month's meeting, the committee voted to post the following policies for public review during the month of February and for final approval on tonight's Board agenda:

f. Student School Board Representatives -

Miss Jessika Gort, High School South Representative, reported as follows:

- 1. Patrick Gould placed 3rd in the PIAA State Wrestling Tournament at 126 pounds. He also broke the school record for qualifying for the most wrestling State tournaments, which is 3 years in a row.
- 2. The Boys' basketball team played in the first round of the PIAA State Tournament. They lost to Lower Merion
- 3. The Boys' Swim team broke school records at districts.
- 4. Spring sports started.
- 5. There was a fundraiser at Texas Roadhouse for the Minithon. The Minithon is an all-night event where money is raised for childhood cancer awareness.
- 6. A couple of weeks ago, students went to the Region Band Festival. Meliksah Dolap qualified for the All-State Band. Region Choir takes place this week.
- 7. On Sunday, the band students will march in the St. Patrick's Day Parade in Stroudsburg.
- 8. The AP Government students raised \$763 through Casual for a Cause Day and \$90 online for suicide prevention and to spread awareness.
- 9. The Musical Production of Mary Poppins will be held on March 29th and 30th at 7:00 p.m. as well as on March 31st at 3:00 p.m.
- 10. The Class of 2020 will host a talent show on April 5th.
- 11. The 17th Annual Perryman Keglovits Foundation All-Star Basketball Games will be held on March 31st in the Koehler Field House –ESU. Girls' Game begins at 4:00 p.m. and Boys' Game begins at 5:30 p.m.

Mr. William Cordero, High School North Representative, reported as follows:

- North had a good start with Spring sports. Track finally used their field. The field is still drying out.
 The baseball and softball teams are sharing a field due to some snow that is on the other field. There is a
 track meet on the 25th in Stroudsburg. There will be a home baseball game on the 23rd against Palisades.
 There is a softball game on the 23rd at Southern Lehigh.
- 2. The Business classes went to Northampton Community College Career Day to obtain information for possible jobs or to get information on the military.
- 3. The High School North's Four Diamond Minithon Club began their fundraisers by selling gold t-shirts for the 2nd Annual Minithon and for research at the Penn State Pediatric Cancer Center. Cans were placed in homerooms for students to donate money. The class that raises the most money will get a free Perkins breakfast.
- 4. Some wrestlers Dylan Hogan, Moshe Mitchell, Cristofer Torres, Wayne McIntyre and Avia Bibeau have qualified at the regionals. Moshe Mitchell took 1st place at 160 and Dylan Hogan took 3rd place at 170.

Mrs. VanWhy asked if this information is an attempt to bring back services that we pay for outside of the district or is this in addition. Mr. Baddick said this is just to share with the Board members and the community the Comprehensive Plan Goals. What Mrs. VanWhy is speaking about will be discussed at a future Finance Committee meeting. His said this information is what he is required, as mandated by the State, to share. Mr. Karkut asked if the \$25,000 fund from the school safety and security grant is different from the grant that Chief Mill is using or is it the same. Dr. Riker said the grant is part A and B. This money is from part A and where every district that applied will get \$25,000. The district has not heard from part B. Mr. Baddick said that the district has a Comprehensive Plan and the Special Education Plan is within the Comprehensive Plan which has to be presented and submitted first. The Comprehensive Plan will follow.

h. Social Service Programming Update

Received part A of the School Safety Grant in the amount of \$25,000 for 2019 for professional development for creating Trauma Sensitive Schools. Dr. Melissa Sadin will work with the school district to meet the district's needs. The district will identify programs, develop action plans and identify assessments, data collection and work in identified cohorts with the district. The district is waiting to see if part B of the School Grant is accepted. If so, the district will get \$37,091.00, which will be used for continued professional development for creating Trauma-Sensitive Schools. Ms. Jones and Ms. Dreisbach invited everyone to Community Night which will be held on May 7th from 6:00 p.m. to 8:15p.m. at Northampton Community College Tannersville Campus-Pocono Hall. There will be a suicide awareness workshop facilitated by Aevidum students. Ms. Debbie Kulick asked if they are notified when there are suicide attempts within our district. Ms. Jones and Ms. Dreisbach said they are informed. Ms. Kulick asked if there are any bullying incidents, can a parent contact them. They said any parent can absolutely contact them.

IX. PUBLIC PARTICIPATION

Limited to comments on this agenda by residents and taxpayers of the school district (3 min. ea.)

- A. Ms. Rebecca Bear said she has an issue with the mold at Middle Smithfield Elementary. She suggested that all schools be tested. He other issue is with the lack of counseling or assemblies given for parents. The event at Northampton Community College is not at a good time for parents to attend. Events should be held at later times or on the weekends. Also, bullying is occurring from teachers and students. Children should be allowed to speak their mind and seek help. Parents should be educated about the resources in the district.
- B. Mr. Richard Key said he finds it a little disturbing that we are not getting all the information about the Middle Smithfield Township occurrence. The attorney that the district hired represented Wayne Rohner personally and cost Middle Smithfield Township about \$20,000. Mr. Rohner wants everyone to feel sorry for him about how they treated him but he is not sharing all the information about his termination. The taxpayers are now paying more tax dollars for an attorney that represented him. How much money is going to him? He said he does not feel sorry for him and what he is saying has no place at this meeting. He said Mr. Rohner has been on the Board since 2015, so what has he done since he has been in the district? Mr. Rohner said, for the record, zero dollars are coming directly to him. Mr. Key said that he hopes the insurance carrier for Middle Smithfield Township go back to Mr. Rohner for the expense they paid on his lawsuit. It may help to alleviate some of the taxpayers' money.
- C. Mr. John Petrizzo said that he commends Mr. Rohner and everyone that helped him out. Middle Smithfield Township is one of the most corrupt areas to live in. Mr. Petrizzo said he was the main complainant against Middle Smithfield Township from the time they laid the foundation and the footers in 5 degrees below weather when the Building Officials Code Administrators (BOCA) code says 35 degrees and above. That area has been a disaster since the beginning. The roof leaks and structural beams are chopped out. There are issues throughout the entire school district. He had suggested that Mr. Rohner contact Lyman and Ash because they will get him his money back. Mr. Petrizzo said he contacted some business owners and three out of four of them said they will run their two-year tax notices out, hand the keys in and then move. These things have been going on for 20 plus years in the school district and he has specifics. He would like to enter into the record information of what Wayne Rohner's successor did in case anyone from law enforcement contact the district.
- D. Mr. Robert Eden said that last month he spoke about the forensic audit and suggested that the district do it. He continues to suggest that they take a serious look about doing it. The corruption and underlying current is there. It needs to be dug out.
- E. Ms. Kelly Vandervliet said she has a daughter at Middle Smithfield Elementary School. She is concerned that although the mission statement on the website speaks about effective communication it lacks in the district. She has to hear about issues that are occurring in the district and at her daughter's school on social media and the newspaper but not from the district. The district website also speaks about the health and wellness of the children. This is not being provided to the students and staff. We need to find a solution to fix these roof problems. We should own up to the mistakes and take the steps to fix the mistakes. The work needs to be done and the air needs to be retested; otherwise, it may cost the district more money down the road with all the lawsuits individuals will have about their health problems.
- F. Mr. George Andrews said the Board placed on the district website information about what they have been working on. They will continue to post updates in order to communicate with the public. Mrs. VanWhy said they are currently doing air quality testing at all schools. Ms. Vandervliet said the district should be proactive instead of reactive and not just post items on the website without prior communication. Mrs. VanWhy said the Board members are aware and are trying to reach everyone and do their best to handle all situations.
- G. Mr. Robert Romagno said that not enough has been discussed in public meetings about D'Huy Engineering who is acting as a general contractor for the improvement projects. This is something that was not needed in the past and now the district is spending a lot of money on them. This is a waste of money and the district should hire someone in-house to work as an engineer. Mrs. VanWhy said that in the past they did not have anyone to oversee the projects and that is why there are many issues. Mr. Romagno said the district should just hire people who do their job and can handle all the projects within the district. His other issue is the engine for the North bus garage that was approved by the Property/Facilities Committee but it was stalled. Now the district is wasting money on the rental while they take their time looking for another company that someone on the Board may have a personal interest in.

X. OLD BUSINESS

Mr. Karkut said that last month he mentioned the possibility of joining the committees. This past month between the Property/Facilities Committee and the Finance Committee, they met for about nine hours in total. Half of the information that was discussed was repeated at the Finance Committee. It's a shame that the whole Board and the public was not able to hear Mr. McIntyre's presentation about the treasurer's report that cleared up many of his questions/misconceptions. Some Board members may think that it will be another long meeting but the committee meetings are repetitive. Mrs. VanWhy said she disagreed in the beginning with Mr. Karkut but now that she sees an item is being brought back to the Property/Facilities Committee, meeting altogether may help with making quicker decisions. It's up to the whole Board if they want to have the two meetings together for a couple of months. Mr. Karkut said we can try it for a couple of months because from a Board perspective, we have been communicating well as a Board. Some items like the generator was thrown back because the timeframe from the warranty was changed. Mrs. VanWhy asked are we considering abolishing the two committees or are we having a work session. Mr. Schlameuss said we can have the Property/Facilities Committee meeting followed by the Finance Committee Meeting. Mrs. Kulick asked will it be a Board meeting or a committee meeting. Mr. Karkut said that it will be a full meeting with approval of items since the whole Board will be there to address them. Mr. Schlameuss said then other items can be dealt with at the other Board meeting. Mrs. Kulick suggested that the Board have a second Executive Session a month, too. Mr. Schlameuss said we need to come up with a date. Mr. Rohner said that the Property/Facilities meets the first Thursday of every month. Mrs. VanWhy said MCTI meets on the first week of each month. Mr. Rohner said the reason the generator was kicked back to the Property/Facilities Committee was because it was not the same as what the Property Facilities Committee approved. Mr. Schlameuss said that the discussion on the table is about the date to meet. Mr. Karkut said why not look at Mondays for a meeting. Mr. Schlameuss said it does not have to be a Monday but some Board members have already cleared the Finance Committee meeting dates. Mrs. VanWhy said it should be every other week to meet aside from the third Monday. Mr. Brown said the Board will need to disband the committees. Mr. Schlameuss said maybe not disband the both Committees but have the two Committees meet on one night. Mrs. VanWhy suggests trying one meeting for a couple a months. Mr. Karkut said if the two Committees meet then the whole Board is not there; therefore, the rest of the Board members will have to trust our opinion. Mr. Gullstrand said that is what happens when the Committees meet. Mr. Karkut said the Committees are just advisory. Mr. Schlameuss said we can bring it back some dates next month in order to start in May. Mrs. VanWhy said they can have their Committee meetings in April and announce a date for May. Mr. Karkut asked if they change the Committee meetings in April, can the combined meeting be advertised in time for May. Mr. Brown said you only need to advertise a day in advance of when the meeting will take place.

ACTION BY THE BOARD:

Motion was made by Robert Huffman to approve the Colonial IU #20 General Operating Budget for the 2019-20 school year in the amount of \$3,578,320.00 with the District's share being \$42,096.28, as previously distributed and presented to the Board. Motion was seconded by Debbie Kulick and carried unanimously, 9-0.

Mr. Karkut said that in the Board previously discussed having a forensic audit done. He believes the district should look at the EBTEP Trust, which is an account that is controlled by the IU 20. We are putting a lot of money in that trust and they should be looked at. Mr. Schlameuss said that we cannot request an audit of an account that is not controlled by the ESASD. Mr. Dymond said the EBTEP Trust pays all the medical bills for the individuals that are part of that group. We should have access to what medications and all expenses that were paid for the district employees. Ms. Kulick said that they cannot request this information because it would be a HIPPA violation. Mr. Schlameuss said you cannot do a forensic audit from another organization that spends the money on our behalf. Mr. Karkut said the reason he is suggesting this audit is because the district still keeps paying a certain amount without knowing all expenses. Mr. Schlameuss said a better option is to have someone from EBTEP come to the district to explain how the money is being spent. Therefore, for example, if the district puts in 10 million dollars and the EBTEP Trust pays out 8 million dollars, then the district should get back two million dollars. Otherwise, they can explain where the 2 million dollars goes. If all questions are not answered, then the district can pursue an audit, if we have the legal authority to do so. Mr. Andrews said Mr. McIntyre should have the details of where all the money goes. We should have the first conversation with him. Mr. Rohner said he thought the Board members were looking to do forensic audit for 2017-2018 school year on all a-z debits and credits. Mrs. VanWhy asked if they will also include the activity funds. Mr. Rohner said he suggests all accounts. Mr. Schlameuss said is there a limit on the amount that will be spent on this audit. Ms. Kulick suggest getting the RFP together and then discuss the cost.

ACTION BY THE BOARD:

Motion was made by Debbie Kulick for the district to advertise an RFP for a Forensic Audit of all accounts that are owned and operated by the School District for the 2017/2018 fiscal year. Motion was seconded by Rich Schlameuss and carried unanimously, 9-0.

Mr. Dymond said that an RFP for a District Solicitor has not been redone. Mrs. VanWhy said we already had an RFP sent out and at the last Board meeting she asked if the Board members wanted to redo the RFP. The majority said no; therefore, they will work from the list that we have. A few Board members wanted to add names to the list but the majority of the Board members did not. Mr. Dymond said we had that discussion but we only had 3 firms that responded to the RFP. Mrs. VanWhy said five firms responded. Mr. Dymond said none of the firms were local. Mr. Karkut said local firms did respond. Mr. Schlameuss said the interviews need to be set up.

Motion was made by Debbie Kulick to adjourn. Motion was seconded by Robert Huffman and carried unanimously, 9-0.

Hi John, I'm sorry I couldn't talk with you today, but I am recovering from Major surgery so I am still pretty weak. Shawn McGlynn did nothing but harass us for years and it got especially bad when we wanted to construct the Indoor, I also had 3 idiot neighbors who said I was ruining the neighborhood by putting up the Indoor arena, we actually only bought the arena to accommodate our Therapeutic riding program. We fought for 2 years, we went thru all the phases, but township meetings and local courts are no good as they are all in bed together, we didn't start to win until we went to the Philadelphia courts, the township appealed all our wins, until we asked for a judgment from the supreme court who said we were in our rights to build the structure as it was agricultural in nature but can also be used commercially. No permits needed... don't know what you are trying to do but I hired independent inspectors from day 1 just to make sure my structure was safe for all of us to use. Even though it wasn't required. The township law firm was Grimm, Biehm and Thatcher attorney John Rice out of Doylestown that the township uses for Everything, I would recommend that you or your lawyer contact the lawyer I used Ed Wild in Doylestown. He can discuss the strategy that he used with you, He may charge you but it would be worth it he is very clever. Just be careful how far you go, I was pissed off and spent all my savings for that fight, I did this as I was harrassed by other zoning officers in other townships in regards to my farming business and had actually moved because of it, I was tired of people being pushed around...I won but I couldn't afford to finish the structure and actually had to declare bankruptcy a year later. I am still trying to recover...
