VI. ADOPTION OF AGENDA

VIII. REPORTS

a. Bond Refinancing

Ms. Jamie Doyle, Public Financial Management, Inc., said she is presenting the report on the refinancing that took place last Tuesday, September 15th via internet access. She displayed the replay of the auction page. The first bid came in at 12:08 p.m. and scheduled to end at 12:15 p.m. The bidders cannot see other bids but can see who is winning. Each are allowed to improve their bid to ascertain the first place position. At the end, Fidelity Capital

Markets had the winning bid of 0.55%. On the bottom of page 1, it shows the interest rates hovering over all-time lows. Page 2 includes a summary of the 22 bids. Fidelity bid two times. Since the district's underlying credit rating is a Aa3 credit rating, all bidders bid without bond insurance. The great credit rating saved the district \$50,000. Manufacturers & Traders Trust Company is the Paying Agent. Page 3 shows the chronology of the 22 bids. The auction was supposed to end at 12:15 p.m. but it was extended by 2.43 seconds. Page 4 indicates that the total amount of the bonds that are being refinanced is \$16,250,000 (2013, 2014AA and 2015). The net local effort savings is \$924,975. In 2021, the savings will be \$22,088 and the bulk of the savings will be in 2022 in the amount of \$888,890. The loan is not extended but the interest rates are being lowered. Pages 5-7 are the details for the short in duration bonds that are being financed. Page 8 shows the total amount that will be needed per bond to pay them off. Page 9 shows the new amortization schedule. The state share is approximately \$107,000 and the districts share as indicated in column show the \$924,974.56 savings to the district. Page 10 includes the underwriter discount which came in at 97 cents per thousand. This was a short issue so we expected the fee to come in lower than the average of \$7.50. The district saved over \$100,000. This is an excellent bond discount. She said she rarely sees commission fees that are under a dollar. In the middle of the page, it shows the settlement date which is scheduled for October 29th. The yield of the issue does not include the underwriter's commission. 0.53% will be reported to IRS. The investors wanted premium bonds so column 3 shows they wanted 3% on the dollar. We were able to downsize the number of bonds which were needed in order to accomplish this refunding. Page 11 is the summary of outstanding indebtedness. The rest of the pages is information on the district's credit report. "Kudos" to the Board and Administration in maintaining the credit rating. In conclusion, Ms. Doyle said she is pleased with the whole process and outcome. She thanked Mr. McIntyre for doing an excellent job on the credit rating call which is more grueling than usual in these challenging times. Mrs. VanWhy thanked Mrs. Doyle for the presentation. Mrs. Bear said all of her questions were answered at the Finance Committee meeting. Mr. Schlameuss thanked Ms. Doyle for her work and for getting excellent savings for the school district.

b. Monroe Career & Technical Institute Update

Mrs. Lisa VanWhy said the average AM and PM session attendance is between 200-206 students. 120 students are virtual. Phase 1 of the roof project is complete and inspections are finished. There are a few punch list items to be completed and probably are done as we speak. Payment of the roof and HVAC were approved. As well as the Federal Government Emergency Relief Grant in the amount of \$144,439.00, the Safe School COVID Grant in the amount of \$89,944.00, The Carl D Perkins Federal Grant from PDE in the amount of \$374,967.00 and a settlement agreement with Barry Isaac in the amount of \$25,000.

c. Colonial IU 20 Update

Dr. Damary Bonilla said that at the last IU 20 Board meeting, they discussed having more focus on the effort with reference to diversity, equity and inclusion similar to what we are doing in the district. She said the district will work together to support this program The focus is to raise cultural awareness and to be a more inclusive organization. The IU 20's Comprehensive Plan is due next year. They are doing a survey to gather information. They will then gather data and identify goals. The ESASD went through the Comprehensive Plan process and knows how long and hard the work was but it was a rewarding process. The Colonial virtual referral program has grown substantially like it has in our district. Last year, the IU 20 had 350 students and this year they have 1,000 students. The IU shifted staff to support the department along with Ms. Renee Harris in order to keep up with the demand. The next IU 20 meeting is next Wednesday.

d. Property/Facilities Committee Update

Mrs. Lisa VanWhy said that the Property/Facilities Committee meeting was on September 5th at 5:30 p.m. The following items were recommended to the Board for approval:

e. Education Programs & Resource Committee Update

Dr. Damary Bonilla said the Education Programs & Resource Committee meeting received an update on the Diversity, Equity and Inclusion that is going on in the district. They spoke about all of the teachers, community members and all who are involved and the work that is going such as the training that the stakeholders will be doing on this important work. There will be a curriculum audit that will take place using Diversity, Equity and Inclusion. They will review to see what is relevant to the interest of the students and what is not. They will also see what

October 7th. An update from Administration will take place. They also had an update from Dr. Vitulli regarding ESACA's enrollment and programs. She invited everyone to attend. Dr. Bonilla thanked all who have joined.

f. Finance Committee Update

Ms. Rebecca Bear said that Ms. Doyle made a presentation regarding the bonds. As you can recall that she had a concern with the underwriter's fee, which was priced at \$7.50 per \$1,000 but the final results came in at 97 cents. She is pleased with this amount and is also glade to hear that there was no insurance cost, which saved the district some more money. Unfortunately, Moody's fee is what it is. We cannot shop around for this type of work. The Committee recommended the Bonds transaction as well as the purchase of computer monitors for all of the teachers in order for them to be able to teach with the two. The Committee also recommended the Property/Facilities invoices that were previously mentioned

IX. PUBLIC PARTICIPATION

Limited to comments on this agenda by residents and taxpayers of the school district (3 min. ea.)

Mr. Schlameuss thanked the administrators, students, parents and community for their help in getting the district through the first few weeks of school. For the most part, students are working their way through their classes at home and online. Tonight, the Board will discuss spectators at competitions. He said they understand about the Governor's order and his Veto. The Board have built in some conditions and will be discussing them later tonight. All comments (emails, texts and calls) which were sent to the Board, have been received.

- A. Mr. Leyti Ndiaye, student, said he was chosen to speak on behalf of DECA. DECA is an organization that teaches kids business skills i.e. Entrepreneurship, Finance and Accounting as well as many more. He has been part of DECA for the past three years, where he learned to network. This year, they encountered a huge setback since they cannot meet in person. They are looking to make DECA virtual. The group is falling extremely behind other chapters because they cannot meet. He said DECA is asking permission to meet because it would help them a lot.
- B. Ms. Michelle Hiller said she knows that the Board is aware about the Bill that was passed with reference to athletics. As part of the agenda's supporting documents page 40c item D. there is a blank space that needs to be filled to indicate the percentage for the total capacity. Will this blank be filled today or looked at since the law changed? The indoor sports have a total capacity of 25 people and in the classroom 25 are allowed. There is a big difference between a classroom and a gym. This amount should be looked at and a percentage should be included. Also, clubs need to be looked at so they can meet virtually.
- C. Mr. David Krupski said he would like to speak on a Social Studies elective. He said it is his understanding that the new course would be in African American History. He heard there is some pushback on it. He believes it would be beneficial to the students and community who have to deal with it on a daily basis. This school district has a checkered history with race and the Board has shown some indifference. Passing on an opportunity like this would further the divide between the community and the Board. Bringing this course on history and different cultures of people around the world, will further students' education and sense of worth. The job of the district is to provide the best possible education; therefore, this decision should be made. There is tension on this issue but he believes that the teachers, students and staff would do justice to this sensitive topic. He implores the Board to do this great measure for our students in helping them get the education that they deserve.

- D. Ms. Kate Briegel, Senior at H.S. South and President of our DECA Chapter, said she heard several scenarios of when clubs will be starting. She is not asking for activity buses but would like to be able to begin meetings virtually. She said they have ideas of meeting online in groups and in clusters in a virtual environment. She said she is willing to set up as many zoom meetings as possible. She has been working very hard to keep members involved locally and within the State, since she is a State Officer. She would like to see growth and have students succeed. Other DECA Chapters are moving forward and she would like the green light in order to start. Other clubs have first year students and DECA does not have them yet. She is asking the Board to approve clubs starting this week in order to get prepared.
- E. Mr. Steven Lurry said he believes that African American History classes are needed. It is American history. With everything going on today, it will help kids understand each other in times like this and in the future. We are in pivotal times where this is needed.
- F. Ms. Alicia Thatch said the African American class should be part of the school's curriculum. Why would there be any pushback? A large percentage of minorities attend the schools in the district; therefore, it would benefit the students. African Americans play a big part in this country's history. It would benefit everyone to fully understand how it benefits this place. Implementing this class would help resolve issues of ignorance and racism.
- G. Mr. Jonah Lurry agrees that the African American class should be part of the curriculum. It is American history and his fellow students are being deprived of this education. It should be taught to all school district students.
- H. Ms. Maria Hopkins said she has spoken to Board members about her feelings about spectators at athletic games. Her concern is about all students being able to participate at the games such as the band students. All students should be allowed before spectators are allowed. If there is space for spectators, then tickets should be given equally to all students' families that are participating.

b. PROGRAMS

i. 123 - Interscholastic Athletics

ACTION BY THE BOARD:

Motion was made by Rebecca Bear to approve the revisions to the Athletics Health and Safety Plan as presented. Motion was seconded by Dr. Damary Bonilla and carried unanimously, 9-0.

Ms. Rebecca Bear said currently the district has to remain having athletic events at the maximum capacity of 250 individuals for outdoor sports until they hear back from the Senate on the Governor's Veto. Mr. Andrews asked if discussion has to be made on what percentage to approve to allow spectators. Mr. Schlameuss said that the only capacity issue is at South. Mr. Andrews said the backup pages 40, 40a-40h and 41-45 need to be discussed with reference to a decision if spectators should be allowed. Mr. Schlameuss asked if Mr. Andrews is making a motion for spectators to be added at non-football home games. Mr. Andrews said they should be allowed for individuals at home and visitors at home games. Dr. Riker said the Board does not need a motion because whatever they decide can be added to the Athletic Health and Safety plan. He suggested that the Board discuss and make decisions on four items: One, middle school sports schedules with reference to whether they will be permitted to compete with other Monroe County teams. Two, is the percentage that will be allowed if the Governor's veto is overwritten. By deciding a number tonight, the Board would not need to reconvene. Three, if the Governor's veto is not overturned, how do we distribute the tickets that are available. Four, is the Board willing to allow spectators from visiting schools. Currently the other Monroe County School Districts have decided not to do that. Mr. Andrews said not allowing spectators was an easy way out for the other Athletic Directors. Mr. Schlameuss asked the Board members if they would like to allow visiting spectators from other districts. Mrs. Bear said that her concern is that the district students would want to come and support their peers. The district should let our parents and students come to the games before allowing spectators from the visiting teams. Mr. Andrews asked if Ms. Bear is speaking about allowing spectators for the cross country matches. Mrs. Bear said allowing spectators at the smaller teams is fine but for football there are too many on the team already. Mr. Andrews said the Board should make a decision sport by sport. Mrs. Bear said she believes that our families should have the opportunity to see their student first. Mr. Andrews said decisions should be made per sport and not make a blanket decision. Mr. Schlameuss asked if there are five people that say "no" to allow visiting spectators. Mrs. VanWhy asked if they are voting on visitors on a sport-by-sport basis. Mrs. Bear said she is okay with all other sports having visiting spectators because most spectators will have video access. What happens to those individuals who cannot watch them on the app? Mr. Andrews said this is a subscription so parents will have to pay for it. Mrs. Bear said parents will have to pay a fee anyway if they go to see their child play away. Mr. Andrews said he was under the impression that this was a free service but parents have to pay. Mrs. Bear said students can view it for free to see previous games. Mr. Andrews said the Board needs to realize that East Bay gave us the TV monitors, but the service is not free. Mrs. Bear and Mr. Schlameuss said if you go to any game, parents have to pay and this service does not cost more than the tickets. Mr. Schlameuss asked if the Board would like to allow 1 ticket per player because we are up in numbers closer to 250 depending on the athletic event. The Boys South Soccer team totals 222 visiting spectators. The Girls South Soccer team totals 185 and the Field Hockey has 218. Mrs. VanWhy said she agrees with Mrs. Bear with allowing our families first before visitors are permitted. Mrs. Bear said there is no way to allow visitors in teams with a large number. Mr. Andrews said the smaller teams should be allowed to have spectators. Mrs. Kulick suggested making one rule for all teams. Mr. Andrews said this would be taking the easy way out. Mrs. Bear said how about not allow any visitors or spectators. Mr. Rohner said that should not be the answer. Mrs. VanWhy said it is not fair for tennis to have spectators and other teams can't. Dr. Bonilla said they need to be consistent across the board. Mrs. Bear said if she has a child that plays tennis, she would not have a video to watch because there are no cameras there. Mrs. Bear said if students play field hockey, parents/families have the opportunity to purchase the app; therefore, she, as a parent, has the opportunity to watch her child when she plays away. Dr. Bonilla suggested reviewing sport by sport in order to make a decision. Mr. Schlameuss said the volleyball team only has 25 people. Mrs. Bear said they do not have spectators. Mr. Schlameuss said the Boys Soccer Team South has a total of approximately 222 in the stadium and North has approximately 225; therefore, there is wiggle room of about 25. Mrs. Bear suggested doing a survey to see who can attend. Dr. Bonilla asked Mr. Schlameuss to indicate whether each sport has video availability. Mr. Schlameuss said Girls Soccer, Boys Soccer and Field Hockey teams have video provided and the game is played on the field. The Girl Soccer North team has a total of approximately 187 in the stadium and the South team has approximately 185 without spectators. Mrs. Bear asked how many spectators is the district allowing for every athlete. Dr. Riker said currently 7 tickets for North and six tickets for South. Dr. Bonilla said since no visiting spectators have been allowed, they can probably be given 20 tickets and still stay under the maximum level. Mrs. Bear asked how would they regulate who gets a ticket. Mr. Schlameuss said tickets can be sent to them ahead of time. Mrs. Bear asked if spectators will September 21, 2020

also have tickets. Mr. Schlameuss said they will get tickets ahead of the season. Dr. Bonilla said if no spectators will be allowed in the boys' team then no spectators should be allowed in the girls' team. Mrs. VanWhy said she agrees. Mr. Schlameuss said that the total numbers in the stadium for Field Hockey are 193 for North and 218 for South. A video is available. Dr. Bonilla and Mrs. VanWhy suggested not having any visiting spectators. Mr. Schlameuss said since the total allowed is 250 they may be able to get one or two tickets. Mrs. VanWhy suggested giving the opposing team the balance of the tickets and let them decide how they will distribute them. Dr. Bonilla said we need to have consistency and equity. If parents have the opportunity to see their children via video, let it be but for the opposing team the Board needs to figure something out. Mr. Schlameuss suggested giving 25 tickets to the opposing team for Tennis and Cross Country. Mr. Andrews said Cross Country is not a spectator sport. If they have 10 individuals, that is a lot. Dr. Bonilla said due to the current situation, many more individuals may want to get out to do something or may want to support their child. Mr. Andrews asked how many are on the Cross Country team. Mr. Schlameuss said they can probably give them about 50 tickets. How many tickets should be given to the Tennis team? Mrs. Bear and Mr. Rohner suggested giving 2 tickets per tennis player per visiting team. Mrs. Kulick said we still have the responsibility to have a safe environment for everyone. Mrs. Bear said there is no seating for tennis spectators. Do we have capacity to fit lawn chairs and social distance? Mrs. VanWhy said it is a big field. Mr. Schlameuss suggested giving 5 tickets for the Cross Country team. All other sports are at full capacity, 250. Further conversation can be had if the Governor's Veto is overwritten. Mrs. Kulick said no further discussion will be needed if the Board sets a percentage. Mr. Schlameuss suggested that they decide the percentage before discussing football. Mrs. VanWhy asked what does this all mean for practice. Mr. Schlameuss said it does not pertain to practice because no one is allowed. Mrs. Bear said parents are never allowed at practices. Mr. Rohner said the reason no one is allowed is due to COVID-19. Mr. Schlameuss said the only sports issuing visitor tickets are Tennis and Cross Country. Dr. Riker said will need to decide the same for JV. Freshman and Middle School sports. This may apply for all of the sports that were previously mentioned but the focus has been on varsity sports. The same would apply for all. Mrs. Bear said JV and Varsity may be included in the same numbers since they play on both teams. Mrs. Schlameuss said they were given numbers for several sport teams but not for football North. Mrs. Bear said golf was not discussed. Mr. Schlameuss said golf does not get spectators. With reference to J.T. Lambert and Lehman Soccer, Field Hockey, and Cross Country, he would suggest having visitors receive 1 ticket, where feasible. Mrs. VanWhy said she agrees. Dr. Riker said the district can take care of the tickets. Mrs. Bear asked if they have tickets for when students play against each other North vs. South. Mr. Schlameuss said they are not receiving tickets for these games that is why everything needs to be figured out. For Tennis, Cross Country and Intermediate sports a few tickets will be distributed to the visitors. If the Senate gets enough votes to overrule the Governor's Veto, we need to set a percentage. Mrs. Bear asked how many seats are in each stadium. Mr. Schlameuss said the South Stadium has 3,800 seats and the North stadium has 1,400 seats. Mr. Andrews asked if there is this much of a difference between the both stadiums. Mr. Rohner said there is. Mr. Schlameuss said if they decide on 50%, social distancing can be controlled. Mr. Schlameuss asked for a percentage from the Board members. The Board's consensus was 50%. Mr. Schlameuss said now they have to decide the number of tickets for varsity football spectators. One option is for the full band to perform at half time but only a couple of students in a pep band can join in the stands when they are done, which would include the seniors staying for the game. The band, cheerleaders and football players would get a certain amount of tickets. Mrs. Bear said why are they kicking out the band students and giving tickets to spectators. Mrs. Schlameuss said another option is allowing all band students to attend and not allowing any spectators. Mrs. Bear said otherwise, you are saying that the band does not matter. Dr. Damary said she does not see it that way. We are trying to please a lot of people in a complicated situation and while being in the middle of a crisis. We need to have flexibility and fluidity as regulations change. Mrs. Bear said if they are limiting band students then why not limit cheerleaders, too, from staying in the game. Dr. Bonilla said we can but you, Ms. Bear, was previously advocating for spectators and now you want to limit cheerleaders. Mr. Andrews said we can limit the football players, too. Mr. Rohner said that is not a good idea. Mrs. VanWhy said what numbers are gained if we eliminate one group or another. How many spectators would be allowed? Dr. Riker said 35-40 spectators would be allowed. Mrs. VanWhy said if that is the number, then it is not worth it. We should allow all students to remain. Mr. Schlameuss said we would still have an issue with 6 band members. Mrs. VanWhy suggested cutting staff. Dr. Riker said we do not need to cut any band members because they all can be accommodated. Mr. Schlameuss said that the Board needs to make these hard decisions. Mrs. Bear said students are more important than spectators. Parents would choose to let their child attend. Dr. Bonilla said she agrees students are important but some parents may not agree with not allowing spectators. We need to be mindful of what we are discussing, in what order and how we are making decisions. Mrs. Kulick said we are saying that students are a priority and they should come first. Mr. Schlameuss said if our position is going to be to allow all band students and no spectators for South, we may have people yelling at us. Mrs. VanWhy said if people are upset that they cannot see their children, then they should talk to their Legislators in order for them to override the veto. Mr. Andrews said the other issue is that the Federal Judge declared the Governor's directive unconstitutional, so we should be allowed to have as many people as we want. Let's see if Governor Wolf can stop us from having everyone. We should open it up to all. How can he enforce a mandate that is unconstitutional? Mr. Brown said there is a difference between the Governor issuing directives to private individuals and organizations compared to him issuing directives to a political subdivision like school districts. Dr. Bonilla said this a discussion for another day. Mrs. VanWhy said what she was trying to say was for the community to put pressure on their Legislators. Mr. Schlameuss said the consensus he is hearing from the Board members is to allow all band students and no spectators. We will give direction to administration to make that happen. The final discussion involves whether to allow intermediate schools to play each other and other districts. Dr. Riker asked if the previous decision that was made included North and South football teams. Mr. September 21, 2020

Schlameuss said the decision was for South only because there is space for spectators at the North stadium. Dr. Riker said there will be room for parents. Mr. Rohner said then parents should be allowed. Mr. Schlameuss said they should be flexible where they can be. Dr. Riker asked Mr. Schlameuss how would the Board like the district to distribute tickets at North because they can start giving to senior students but they would run out of them very fast. There would not be enough for every football player, band, or cheerleaders. Mr. Rohner said give tickets to all seniors. Mrs. VanWhy asked if there are enough tickets for all seniors. Dr. Riker said he can distribute the tickets to all senior students involved. Mr. Schlameuss said a decision has to be made about the middle school athletic competition. Does the Board want to allow the teams to play with other teams from Monroe County? Mr. Rohner said yes. Mrs. Bear said they should be allowed to play with other Monroe County teams if parents are comfortable with traveling to other districts. Mr. Andrews said what is the difference if they travel from North to South or if they travel to other districts. Mrs. Bear said some parents have concerns about traveling out of the district. Ms. Glasco said parents should be able to make that decision without any penalties to the student. Mr. Schlameuss said during these COVID times, parents will need to make the decision that is best for them and their child.

The Following decisions from the Board will be added to the Athletic Health & Safety Plan

- 1. Boys' soccer, Girls' soccer, and Field Hockey. Allow home spectators and visiting spectators, where feasible. Video will be available.
- 2. Volleyball No home spectators/no visiting spectators. Video will be available.
- 3. Tennis Home spectators allowed and 2 tickets for visiting spectators will be distributed
- 4. Cross County Home spectators allowed and 5 tickets for visiting spectators will be distributed
- 5. Freshman, JV & Flag Football, Soccer, Field Hockey and Cross Country Visitor tickets will be distributed, where feasible
- 6. If Governor's Veto fails, ESASD will permit 50% of a venue's total allowable capacity.
- 7. If Governor's Veto does not fail, no spectators allowed at the South Stadium only football players, band students and cheerleaders along with coaching staff and administrators as well as visiting team will be allowed.
- 8. Spectators allowed at North Stadium. Distribute tickets starting with senior participants (football, cheerleaders and band students)
- 9. Middle School sports are allowed to play with the Monroe County teams. Parents will be able to make that decision with no penalty to student, if they chose not to play.
