123. INTERSCHOLASTIC ATHLETICS	
1. Purpose	The Board recognizes the value of a program of interscholastic athletics as an integral part of the total school experience for all school district students and as a conduit for community involvement.
2. Definition	For purposes of this policy, the program of <b>interscholastic athletics</b> shall include all activities relating to competitive or exhibition sport contests, games or events involving individual students or teams of students when such events occur between schools within this school district or outside this school district.

Authority <del>SC 1601-C et seq.</del> Title 22 Sec. 4.27 34 CFR 106.41 Pol. 103  SC 511  Pol. 204, 209	<p>It shall be the policy of the Board to offer opportunities for participation in interscholastic athletic programs to male and female students on as equal a basis as is practicable and without discrimination, in accordance with law and regulations. <a href="#">[1]</a><a href="#">[2]</a><a href="#">[3]</a><a href="#">[4]</a><a href="#">[5]</a></p> <p>The Board shall approve a program of interscholastic athletics and require that all facilities utilized in that program, whether or not the property of this Board, properly safeguard both players and spectators and are kept free from hazardous conditions. <a href="#">[6]</a></p> <p>The Board shall adopt an Athletic Handbook to govern student participation in Interscholastic Athletics. Each student must adhere to Board Policies, Student Code of Conduct, and the Athletic Handbook.</p> <p>The Board shall determine the standards of eligibility to be met by all students participating in an interscholastic program. Such standards shall require that each student, before participating in any interscholastic activity, be covered by student accident insurance; <del>be in good physical condition; and</del> be free of injury, <u>and undergo a physical examination by aas determined by the school district</u></p>

	<p><u>licensed</u> physician.[6]</p> <p>The Board further adopts those eligibility standards set by the Constitution of the Pennsylvania Interscholastic Athletic Association, and the Athletic Handbook.</p>

<p><del>SC 511</del></p>	<p>The Board directs that no student may participate in the program of interscholastic athletics <del>who has not:[6] if s/he has not maintained a record of academic proficiency that satisfies guidelines set forth by the P.I.A.A. and is sufficient to insure that participation in interscholastic athletic activities will not interfere with his/her instructional program.</del></p> <ol style="list-style-type: none"> <li><u>1. Met the requirements for academic eligibility that satisfies guidelines set forth by the P.I.A.A and is sufficient to insure that participation in interscholastic athletic activities will not interfere with the student’s instructional program.</u></li> <li><u>2. Complied with the requirements of the Athletic Handbook.</u></li> <li><u>3. Complied with the requirements of the Code of Student Conduct for Interscholastic Athletics and Board policies and administrative regulations related to student discipline.</u></li> <li><u>4. Attended school regularly.[7]</u></li> <li><u>5. Been in attendance on the day of the athletic event or practice for the hours required.</u></li> <li><u>6. Returned all school athletic equipment previously used.</u></li> <li><u>7. Adhered to applicable discipline standards.[8]</u></li> </ol>

<p><del>Pol. 137</del></p>	<p><del>A charter or cyber charter school student may participate in the school district’s interscholastic athletic programs as long as the student is a resident of the school district, the charter or cyber charter school does not provide the same interscholastic athletic program, and the student fulfills all requirements for participation in the program required for school district students. The opportunity for such participation may be rescinded for cause by the Superintendent or designee.</del></p> <p><del>A home education student may participate in the school district’s interscholastic athletics program as long as the student is a resident of the school district and the student fulfills all requirements for participation in the activity required for school district students. The privilege of participation in interscholastic athletics may be rescinded for cause by the Superintendent or designee.</del></p>

<p>4. Delegation of Responsibility</p> <p><del>Title 22</del> <del>Sec. 12.1, 12.4</del></p>	<p>The Superintendent or designee shall annually prepare, approve and post a complete schedule of events on the school district’s website.</p> <p>She/he shall update that schedule as changes occur and post to the website as necessary.</p> <p>The Superintendent or designee shall prepare rules for the conduct of students participating in interscholastic athletics. Such rules shall be in conformity with regulations of the State Board of Education, the P.I.A.A. and the school district.</p> <p>The Superintendent or designee shall ensure that similar athletic programs are offered to both sexes in proportion to the school district’s enrollment.</p> <p>The Superintendent shall ensure that interscholastic athletics are open to all eligible students and that all students are fully informed of the opportunities available to them.<del>[13][14]</del></p>
<p>5. Guidelines</p>	<p><del>Each school year, prior to participation in an interscholastic athletic activity, every student athlete and their parent/guardian shall sign and return the acknowledgement of receipt and review of the following:<del>[9][10][11][12]</del></del></p> <ol style="list-style-type: none"> <li><del>1. Concussion and Traumatic Brain Injury Information Sheet.</del></li> <li><del>2. Sudden Cardiac Arrest Symptoms and Warning Signs Information Sheet.</del></li> </ol> <p><del>The Superintendent or designee shall annually prepare, approve and present to the Board for its consideration a program of interscholastic athletics, which shall include a complete schedule of events.</del></p> <p><del>Male/Female Athletic Opportunities Report</del></p> <p><del>By October 15 of each year, on the designated disclosure form, the Superintendent or designee shall report to the PA Department of Education the interscholastic athletic opportunities and treatment for male and female secondary school students for the preceding school year.<del>[15]</del></del></p> <p><del>By November 1 of each year, the completed disclosure form shall be made available for public inspection during regular business hours and posted on the district's website.<del>[15]</del></del></p> <p><del>The availability of the completed disclosure form shall be announced by posting a notice on school bulletin boards, in the school newspaper, on any electronic mailing list or list serve, and by any other reasonable means.<del>[15]</del></del></p> <p><del>Staff</del></p> <p><del>All teaching staff, support staff, and members of the community who meet the</del></p>

~~requirements of the job description and legal requirements shall be eligible to serve as an activity sponsor or athletic coach. The selection process shall be governed by the appropriate collective bargaining agreement with teaching staff receiving first consideration.~~

~~Athletic coaches must be knowledgeable regarding training and conditioning and sports skills as evidenced by appropriate course work either completed or being taken, past experiences or responses to questions during interviews for a coaching position.~~

~~Because of the extent of responsibilities in many areas of school operations, school district administrators shall be eligible to serve as volunteers to assist coaches, directors or advisors for any scholastic or intramural program or activities program; but, only after completion of their normal daily administrative duties.~~

~~All appointments to extra-responsibility positions are for a one-year period only.~~

A coach must upload a copy of the transcript indicating satisfactory completion of the course(s) to the PIAA Website for credit. In addition, American Red Cross First Aid training will also be accepted for the first aid requirement.~~

<p><b>Pol. 218</b></p>	<p><u>Off-Campus Activities</u></p> <p>This policy shall also apply to student conduct that occurs off school property and would violate the applicable <del>student</del> Code of <u>Student</u> Conduct if <u>any of the following circumstances exist:</u><sup>[8]</sup></p> <ol style="list-style-type: none"> <li>1. <u>The conduct occurs during the time the student is traveling to and from school or travelling to and from school-sponsored activities, whether or not via school district furnished transportation. There is a nexus between the proximity or timing of the conduct in relation to the student’s attendance at school or school-sponsored activities.</u></li> <li>2. The student is a member of an extracurricular activity and has been notified that particular off-campus conduct could result in exclusion from such activities.</li> <li>3. Student expression or conduct materially and substantially disrupts the operations of the school, or the administration reasonably anticipates that the expression or conduct is likely to materially and substantially disrupt the operations of the school.</li> <li>4. The conduct has a direct nexus to attendance at school or a school-sponsored activity, such as an agreement to complete a transaction outside of school that would violate the student Code of <u>Student</u> Conduct.</li> <li>5. <u>The conduct involves the theft or vandalism of school property.</u></li> <li>5.6. <u>There is a nexus between the proximity or timing of the conduct in relation to the student’s attendance at school or school-sponsored activities.</u></li> </ol>
	<p><u>Rules At Athletic Events</u></p> <p><del>As members of the Eastern Pennsylvania Conference (EPC), the schools of the school district are firmly committed to the belief that athletic competition is a vital part of our educational program. The EPC and ESASD expect its member schools to exhibit only the highest standards of sportsmanship. Events at ESASD will adhere to the following</del></p> <ol style="list-style-type: none"> <li><del>1. Bookbags may be subject to search at athletic events.</del></li> <li><del>2. No alcoholic beverages or use thereof are permitted at any athletic contests.</del></li> <li><del>3. Players, coaches, and fans are asked to refrain from the use of foul, abusive and/or abrasive language.</del></li> <li><del>4. The throwing of objects onto the playing area is strictly prohibited.</del></li> </ol>

	<p><del>5. Anyone intoxicated or exhibiting behavior unbecoming a sports fan will be ejected from the playing area.</del></p> <p><del>6. Anyone who is ejected from the gym/playing area due to lack of compliance with any of these rules will not be granted a refund and may be subject to police investigation.</del></p> <p><del>7. It is expected that all spectators will extend every possible courtesy to both teams competing by exhibiting good sportsmanship throughout the contest.</del></p> <p><del>8. Home and visiting spectators are asked to remain in designated areas.</del></p> <p><del>9. All spectators are to keep off the playing area at all times.</del></p> <p><del>10. No one will be allowed to leave the school building/stadium and return once a varsity contest begins without permission.</del></p> <p><del>11. Any kind of liquid refreshment must be consumed in designated areas.</del></p> <p><del>12. As per P.I.A.A. guidelines, noisemakers and signs are not permitted in a gym during any athletic contest.</del></p> <p><del>13. At any time that it becomes necessary due to lack of compliance with these rules by a large number of fans, the playing area will be cleared of spectators (without refund of admission price), and the contest will be concluded in closed session.</del></p>
