#### V. APPROVAL OF AGENDA

# VI. ITEMS REQUIRING ACTION

#### a. District Door Replacement(s) - J.T. Lambert and Lehman Intermediate

The doors at each location, J.T. Lambert and Lehman Intermediate have numerous maintenance repairs to the doors, panic bars, latches, etc. This is also a security concern if entry/exit doors are no longer latching and secure. According to A.G. Mauro, who also provided us with the lowest quote for both locations, stated that there are supply concerns for product. If we order the necessary items now, then the items may be ready for install in July of 2022 without a delay. Mr. Ihle explained that these doors have been budgeted for the 22-23 Facilities Department Budget.

#### b. Middle Smithfield Elementary Gym Floor Refinish

Robert Romagno originally brought this to the Committee in December of 2021, but at the time, only received one quote. Robert has created a 5-year plan for gym floors to be refinished. The first one needing to be refinished is Middle Smithfield Elementary. Wayfare Sports Floors has provided the lowest proposal and they are a contracted Costar vendor. The services performed would be refinish, reline and restriping of the gym floor. This project is slated to be completed in July of 2022 and is budgeted for this

year. Dr. Riker stated this is a continuous preventative maintenance task.

## c. Hilltop Sales and Service – John Deer Tractors for J.M. Hill and Smithfield Elementary

Robert Romagno stated that this request has been turned down the past three years. These items are budgeted for the 22/23 year. Robert previously reached out to the Finance Committee to start talking about vehicle replacements. The current tractors at both locations have extreme wear and tear. One of the tractors is rear wheel drive and not efficient for what they need it to do. Dr. Riker explained that there are funds in the Capital Reserve to support these purchases. If approved now, the delivery of these items should be in the 22/23 budget and will allocate the funds to the appropriate year. If new tractors are approved to purchase, the old tractors may be auctioned to recoup some money.
