e. Middle Smithfield Elementary – Emergency Sprinkler Fire Pump Repair

William Gouger spoke to the committee regarding the need for an emergency sprinkler fire pump repair at Middle Smithfield Elementary. He stated that the controller for the fire pump system was fried. Keystone Fire and Security arrived to review the controller and it is beyond their scope of work. They had a special technician arrive and he went through the system and found melted springs that were welded to contactors. They are speculating that a power surge may have been the cause of this, but unfortunately there is no known cause. This system is checked once a year and went faulty about 3 months ago. This is an emergency repair, there is a 6-8 week lead time on parts, but they have already been ordered.

a. High School North Weight Room

Mr. Robert Romagno wanted to bring this to the committee's attention. The weight room is above Shipping and Receiving on the North Campus. D'Huy Engineering has looked into this and is monitoring the cracks. The wall that is not load bearing but has fire insulation and caulking and that of that is falling out and overtime will get continuously worse. Chuck Daly would like to get quotes for a metal pole building. This will be presented to the committee on a future date.
