a. Property and Facilities 2023 Meeting Dates

b. High School South and East Stroudsburg Elementary Gym Floor Refinish

This is Phase 2 of Environmental Services Department for the District to refinish gym floors. High School South Auxiliary Gym has not been refinished since 1988. Wayfare Sports Floors just completed J.M. Hill's gym floor over winter break. Wayfare Sports is a costar vendor and has had other projects throughout the District. These floors are slated to be refinished over the summer. This is budgeted out of Capital Reserve.

VII. ITEMS FOR DISCUSSION

a. High School South and North Laundry Units

Denise Rogers worked with Robert Romagno to present this to the committee. Denise went over bills from our current vendor who launders all uniforms and our annual expenses to launder uniforms is quite expensive. If the district purchases washing units for both North and South schools, the units would be paid off within a year.

b. Current Capital Payments

c. 5-Year Capital Plan

The district is looking to change this to a 7-Year Capital Plan which would include roof life expectancies, buses, JTL Auditorium upgrades. Josh Grice from D'Huy Engineering will be assisting in this change over. Lisa VanWhy approves to have further investigation.

Lisa VanWhy approved new underground oil tank at North Campus. Rob Romagno and Daryle Miller spoke how there is water currently getting into the tank we have on site. Rob is having the biggest tank that can be delivered without the need for a permit, delivered on this month.

Wayne Rohner asked the committee what is the status of the fire panel at our elementary school? Dr. Riker responded that the panel has been installed. Wayne also asked if a permit was needed? As per Chief Mill, the township accepted the new fire panel.

Wayne Rohner asked about the fire sprinkler system at another elementary school. Dr. Riker stated the District is working with Chris Brown and Lyman and Ash regarding this matter.

Wayne Rohner made a statement to the committee that Bushkill Fire Department responds to fire alarms. Wayne is adamant that there is a manual for the fire alarm sensors and would like to know where it is to assist the Fire Department. According to Wayne, the Fire Department has to pull/remove multiple tiles to find the sensors.

Larry Dymond suggested a propane tank instead of an oil tank at the North Campus. He stated it lasts longer, cheaper, and less maintenance.
