#### VII. APPROVAL OF MINUTES

## **ACTION BY THE BOARD:**

Motion was made by Debbie Kulick to approve the minutes of the July 17, 2023, Board meeting. Motion was seconded by Jason Gullstrand and carried unanimously, 8-0.

#### VIII. REPORTS

a. Monroe Career & Technical Institute Update

Mrs. Lisa VanWhy said the JOC met on August 7<sup>th</sup> at 7:00 p.m. We heard a presentation from CrabTree on the design of the addition. They showed us the layout and the plan. After several questions and concerns, the project is moving forward as planned. We approved various service agreements. We approved Northampton Community College as an emergency facility. We approved an MOU for Redevelopment Authority for the Whole Home Repair Program supported by Ace Building and Maintenance Program. We approved a weekly mowing contract for three years along with the sale of computers that are no longer being used. Lastly, we approved the Free Lunch and Breakfast Program, which is great because it will coincide with our program here at ESASD. The next JOC meeting is scheduled for Monday, 9/11/23, at 7:00 p.m. By the way, we had a massive storm afterwards and that was the excitement we had. It trapped us there for about two additional hours.

## b. Colonial IU 20 Update

Dr. Damary Bonilla said the CIU 20 Board of Directors will meet this coming Wednesday, August 23<sup>rd</sup>. Therefore, I do not have an update tonight.

c. Property/Facilities Committee Update

Mrs. Lisa VanWhy said the Property/Facilities Committee met on August 2<sup>nd</sup> at 5:30 p.m. Items on the agenda with our recommendation are:

- High School South and High School North scoreboards for baseball and softball funded by St. Luke's.
- Lehman Intermediate Concession Shed funded by St. Luke's.
- H.S. North and Lehman Intermediate Storage Garage funded by St. Luke's.
- Trane Service renewal
- Equipment Controls from Trane for Resica Elementary, Lehman Intermediate and High School North HVAC Project pending final Board approval of the project. This project is not to exceed \$7.5 million. \$5 million will be paid by ESSER III Funds. This includes the H.S. North and Lehman Intermediate rooftop equipment replacement and Resica Elementary HVAC improvement. We are moving this project forward because of the timing of the ESSER III funding and this is also an Omnia Federal Purchasing bid. Our CFO recommends moving forward with this project due to the ESSER funding.
- Also on the agenda are D'Huy Engineering invoices 1-4 on page 18 along with several Application for Payments. The next meeting is scheduled for September 6<sup>th</sup> at 5:30 p.m.
- d. Education Programs & Resources Committee Update <u>-esasd.net/epr</u>

Dr. Damary Bonilla said the Education Programs & Resources Committee met on August 9th at 7:00 p.m. via Zoom. We had an update from the BeAlliance, which included a notice that the first coffee chat will be in September. We, at each month, learned about different observances. We also had a Communications update from our Communications Department and that was extensive. We definitely want people to access the information. The QR Code for the EPR content is on the agenda this evening you can either scan it and go online or go directly on the website to be able to access the content. One of the exciting thing was the reminder that there are six Billboards that are displayed throughout the community regarding information for registration for students, regarding open positions and just good visibility for our school district. Also information was shared about having bus schedules on the students' portals. Everything was scheduled to go out today and I can vouch for that because as a parent, I received the information today. We received our busing and class schedule information. We are ready to go for the new school year. We also had an update regarding ESACA, our in-house cyber program. The information contained the numbers, the programs and photos of activities that were going on there. We also had an update regarding the dual enrollment. I am unsure if people realize the value that we have in our school district where parents and guardians would only pay \$30 for a 3-credit class up to 2 classes. There is a lot of detail that goes into that but there was thoughtful work done to put together the documentation and information. If you are not aware, please reach out to your school administration to access information for your student. It is such an asset to our students and families to be able to take these dual enrollment classes. We also had an update regarding our 2023 STEAM'R

Program. Mrs. Angela Byrne, Grants Writer, who does an amazing job for the school district to bring in funding for supplemental programs, for resources and support for families and community. The STEAM'R Program is one them. Several of us had the benefit of having our students as part of that when they were in elementary school. It was a really good opportunity for students and families to engage in these activities. Our Committee reviewed recommendations that went to the Finance Committee and/or the full Board. We had things like Global Vending Machines, Coding Software, McGraw-Hill, Smartpass, Super Kids Handwriting Materials and others that you will hear from the Finance Committee. Our next meeting is on September 13<sup>th</sup> at 7:00 p.m. via Zoom. We welcome anyone who would like to join because that will be the first meeting of the school year. Mr. Schlameuss said I believe I heard you say that class schedules were released today. Is that correct? Dr. Bonilla said we received the information in Sapphire. There was an announcement as well. It was discussed in the EPR Committee, too. It has been shared widely. Some individuals received theirs already. The newer middle school students received their information last week. The planned date was August 21<sup>st</sup>. Mr. Schlameuss said I am confirming that by looking at my Sapphire account, my children's information is all there.

## e. Finance Committee Update

Mrs. Rebecca Bear said the Finance Committee met on August 14, 2023. The Committee spoke about:

- A quote for Everyday Speech
- A quote for Super Kids
- A quote from Stotz & Fatzinger Office Supply, for a special education classroom at H.S. South, which is paid through ACCESS Funds.
- A quote for TeachTown

We approved the disposal of 2008 White Ford Expedition police vehicle to Harry You Pull it in Allentown. We will be getting \$900 for it.

We approved the motion to approve the equipment and controls presented by Trane, which Mrs. VanWhy spoke about.

We had a discussion with Trane about why we made the choice we made in the facilities that we did for our HVAC.

We also spoke about a lot of things that Mrs. VanWhy spoke about, i.e. South & North scoreboards for baseball and softball, Lehman Intermediate concession stand and North/Lehman storage shed, which are all funded by St. Luke's.

We spoke about Trane R'newals for North and Lehman, H.S. North and Lehman rooftop equipment replacement and the Resica Elementary HVAC.

We also had recommendations from the Education Programs & Resources Committee, i.e. Global Vending Group, which is for the elementary schools to use as a reward. When they get a reward, like good choice dollars, that I knew about when my kids were in elementary school, they can use that money to buy books from the vending machines. They also recommended Code HS, which is a coding software renewal, McGraw-Hill Reveal math and materials, which is a pilot program being paid through ESSER III. Also recommended was HMH ELA support materials, which is also a pilot which is being paid through ESSER III. They approved Zaner-Bloser for Super Kids which is for additional materials for K through 2, Smart Pass, which is a cool concept, which is also paid through ESSER III for an electronic hall pass system. HMH Read 180, which is a two-year proposal for intermediate paid by ACCESS and ESSER III, Zaner-Bloser for Super Kids for 2<sup>nd</sup> grade for two backpack pages paid through ESSER III, Zoner Bloser handwriting for grades 3-5 for all elementary schools and additional materials for J. M. Hill Elementary, paid through ESSER III and Zaner-Bloser materials for Bushkill Elementary were also approved.

We also had a discussion about a letter being sent to Harrisburg in regards to supporting a drilling tax. Mr. Bard is working on drafting that. We will approve next month at the Finance Committee to forward to the full Board. It is just asking for Harrisburg to consider using the drilling tax to fund education.

The next meeting is scheduled for September 12, 2023 at 5:30 p.m. in the Administration Building as well as via Zoom.

Ms. Debbie Kulick said after not having many policies for these past months, we covered many tonight. The Policy Review Committee met earlier tonight and reviewed the following policies:

## IX. PUBLIC PARTICIPATION

Limited to comments on this agenda by residents and taxpayers of the school district (3 min. ea.)

- A. Mr. Barry Krammes said I would like to discuss athletics. This year was the ninth year that we have had the Jav Festival. I would like to show my gratitude for everyone who has supported us. The night that we had it, Dr. Riker came to support us. Mrs. VanWhy helped me to get a world-class Javelin runway a couple of years ago. We have had some world-class results because of that. Not a lot of people in the community know this but three years ago, we had the American record on the woman's side here in East Stroudsburg. We held that here and it was pretty special. We had 188 people participate this year. In over 100 kids, we had about 8 students from East Stroudsburg South participate. I just want to show my gratitude to the custodial staff, maintenance, police officers and everybody who helps me to put that event together. I also want to say thank you. I would like to give a shout out to the Quick Start Program. My son is starting Kindergarten in the fall. What an awesome program for him to go in to see what the curriculum was like. We are going to get him adjusted because he is very shy. He is a little scared about starting Kindergarten. For him to get adjusted to that and get used to what it is like to go to school. He experienced going in early, having lunch and sitting there with lunch ladies and all that was very cool. I also saw the community come in and take advantage of the food program as well. I want to mention the couple of things that we are doing really good with. Thank you.
- B. Mr. Jacob Morris said I would like to thank the Finance Committee for its approval of my proposal about the School Board drafting a letter to the local elected representatives and to the Statewide School Board Association calling for an extraction tax on fracking gas here in Pennsylvania. As most people know, Pennsylvania is the second largest producer of gas in the United States. Texas is number one and they have an extraction tax. With the court decision stating unequivocally that the use of property taxes to fund school districts Statewide is inherently inequitable and unconstitutional, members of the Administration and most citizens and taxpayers of Pennsylvania would agree that the real solution is another major source of funding to even out the inequitable distribution of funds and the disparities between rich school districts and lower income school districts. That can be very substantial for our Board to send this initiative, because it really shows leadership. I think it would send a message to those in power in our State Legislator that this is really grassroots and that maybe they should pay attention this. Gov. Wolf tried for many years to get an extraction tax on gas and he was stonewalled. I want to state that I am absolutely opposed to voting on the Trane contract for \$7.5 million. I feel that a life-cycle analysis should have been done for heat pumps as an alternative. The life cycle on this equipment is 20-25 years. I would like to point out the youth in Montana won a huge court decision this past week that called for the State of Montana to consider environmental factors and decision making regarding major corporations. That should also be applicable to Pennsylvania.

## X. UNFINISHED BUSINESS

A. I have updates to questions that were presented last month by Mr. Rohner. The very next day we all got an update on the questions that he posed. I want to share with the public the answers to those questions because I think that it is important that the public hear the other end of what is brought up. We are trying to be accommodating going forward.

The first item pertained to the Seven-on-Seven North Football Event. The communication we received from the North Athletics Director and the Director of Transportation stated no request for district transportation had been received by the North team coach to the Seven-on-Seven football event. The coach approached Mr. Rohner at the North Football field on July 7<sup>th</sup> to find out who he was. Mr. Rohner proceeded to ask various questions specifically about getting the bus for the Seven-on-Seven because South was able to get one. The coach informed Mr. Rohner that he did not need a bus because they were not going to the Seven-on-Seven event. The coach said that the team needed to work on many more fundamentals at this point and were not ready for a Seven-on-Seven event.

The next question that was brought up was about water coolers for North. The North Athletic Director said the water cooler concern was a miscommunication between the coach and the athletic trainer. This occurred in the beginning of summer and not recently. It was immediately corrected. In an organization this size there are many moving parts. Miscommunication as well as many other variables can cause some of these things to go wrong or be miscommunicated.

Also shared with the public and the Board, was a picture of chairs that were thrown out. The update we got from North is that there were a number of broken and unusable chairs that were discarded. However, currently there are 90 plus remaining in storage because we have not yet found a home for them. In the future, the Property/Facilities Committee will be updated to make decisions on what to do with items that need to be discarded, sold, etc.

Another question that was raised was about the North graduation. It was asked why they did not have the honor tassels. Right before this meeting Mr. Schlameuss found out that all students received their honors tassel before graduation.

Mrs. VanWhy said to Mr. Rohner you asked what is going on with the bus garage. Mr. Andrews also inquired about the bus garage because someone from the public had a concern. I informed Mr. Andrews that I would put it on the next Property/Facilities Committee agenda as an item for discussion. Obviously, I have not spoken to anyone at Administration about this topic but we will discuss it at our next Property/Facilities Committee meeting.

- B. Mr. Schlameuss said to Mr. Rohner your next question was when will the students and parents find out about their bus routes. Mr. Rohner asked what is the game plan. Mr. Schlameuss said I imagine that will be done by the district before the first day of school. Dr. Bonilla and Mrs. Bear said they received their students' information today. Dr. Bonilla said it was scheduled to go out today and it went out according to plan. Mr. Rohner said he was receiving calls over the weekend.
- Mr. Schlameuss said you also had a question about a bus stop. Mr. Rohner said there is a Facebook post that we are dropping off kids on Hollow Road and Shawnee Valley Road. The Facebook post says that the Board made that decision. Mr. Schlameuss said do you believe everything you ready on Facebook. Mrs. VanWhy said please do not. Mr. Rohner said we used to go into Shawnee Valley drive where there is a parking lot turnaround. I don't know any particulars about that bus stop; therefore, I am looking for a public discussion. Mrs. VanWhy said we can have Administration give us an update at the next meeting. Mr. Schlameuss said I am sure there will be information about that very soon. Dr. Bonilla said this is, again, the same thing that happened last month. The person who has the information to respond is not present because we are not letting Administration know in advance what the concerns are. Mr. Rohner is getting calls at home, and I appreciate that he wants to be a voice for the community, but we have channels of communication. We should be informing the people who they should call. We should have these discussions in advance so that we come here with questions and answers like Mrs. VanWhy just did. This would avoid having to wait and go back and forth instead of thinking that there will be a response right now. What are the chances of that happening. The miscommunication that Mrs. VanWhy alluded to when she gave her update is caused by this blindsiding, by throwing things on the agenda last minute. Instead you should be following protocol particularly at a sensitive time when we are about to start a new school year in a week. We have to do better. Mr. Rohner said I was just taking advantage of a public meeting. Mr. Schlameuss said if you would have emailed the Board and Dr. Riker that question this morning, we could have had an answer for you today at this meeting. Instead, I have to say to you now we have to wait and figure that out and get back to everyone. I am pretty sure they don't have an answer sitting at this table. Mr. Rohner said it sounds like the answer is that it went out today. Mr. Schlameuss said the information went out today but we do not know the disposition of that specific bus stop that you are asking about. It would be helpful to help us by getting the questions out before the meeting so that we can have answers, versus saying we will just have to wait. Mrs. Bear said I am sure Mrs. Robins would have been more than happy to answer that question or come to the Board meeting if there were questions about that stop. I know she was upset last month when she was not asked the question about the North buses for the game. Mr. Schlameuss said yes, I heard that she was concerned that she did not know anything about a request for North buses. Mrs. Bear said Mrs. Robins thought she had missed the request. Mr. Schlameuss said, but she didn't. Mr. Rohner said he had a conversation with Mrs. Robins and made it very clear to her that she didn't miss anything.
