A. Subdivision Plan and Stormwater Drainage System

ACTION BY THE BOARD:

Motion was made by William Searfoss to approve that the Proposed Subdivision Plan and the proposed stormwater drainage system for the Terra Greens project be revised in accordance with the proposed Subdivision Area Revision submitted by Niclaus Engineering. This will result in an increase of the total land area purchased by the District by approximately 2.5 acres. Motion was seconded by Christopher Baj. A roll call vote was taken. Those in favor were William Searfoss, Christopher Baj, Horace Cole, Bet Hays, Donald Motts, and Michal Peterson. Opposed were Robert Gress and Keith Karkut. Motion was carried, 6-2.

Executive Session

Patricia Baughman informed the Board that she spoke to Mr. Sweet, Attorney, regarding who is part of the negotiations team. When asked about each member, Ms. Baughman was given clearance for William Searfoss and Donald Motts. Mr. Gress was not due to having his wife as part of PSEA. Act 93 is not part of a union because they meet and discuss but teachers are part of the union. Although teachers and support staff members are not on the same contract, the union representative heads both unions.

Bet Hays feels that is not correct and suggested that Ms. Baughman call them back to inform Mr. Sweet that the teachers' contract was already negotiated. Bet Hays also suggested calling the Ethics Commission.

Christopher Baj volunteered. Michal Peterson and Bet Hays said they can be alternates.

Keith Karkut asked if he'll be able to vote on the contract because his wife works in the cafeteria. Or can he just vote on certain sections. Will he be able to be part of executive sessions when discussing the contract?

Tom Dirvonas said he's not sure but will get back to the Board.

Patricia Baughman said she would look into all of the Board's questions and get back to them.
