To the extent that this expenditure is determined to be an emergency under Section 751 of the School Code, the officers and agents of the District are authorized and directed to request approval from the Department of Education. Motion was seconded by Robert Gress. A second motion was made by Christopher Baj to table this motion. The motion was seconded by William Searfoss and carried unanimously 9-0 to table the motion.
