A. Agreement with PPL

ACTION BY THE BOARD:

Motion was made by Christopher Baj that the Board enter into a partnership agreement with PPL for the stream bank stabilization of the Walker property as set forth in the November 14, 2005 correspondence and enclosures from SITE TECH, INC. This will result in PPL being responsible for engineering fees and for payment of \$275,000.00 toward the total estimated cost of \$883,374.00 with the District's share being \$608,374.00. To the extent that this expenditure is determined to be an emergency under Section 751 of the School Code, the officers and agents of the District are authorized and directed to request approval from the Department of Education. Motion was seconded by William Searfoss. A second motion was made by William Searfoss to table the motion. Second motion was seconded by Christopher Baj and tabled unanimously, 8-0.

B. High School South Project Payment

ACTION BY THE BOARD:

Motion was made by Christopher Baj that, with regard to the High School South Project, the Board authorize a payment or contribution to the Borough of East Stroudsburg of fifty (50%) percent of the cost of installation of traffic signals at the intersection of East Broad Street, West Broad Street and North Courtland Street, estimated at \$75,000.00. The Solicitor is authorized and directed to notify the Borough of this action and to prepare an appropriate agreement between the District and the Borough evidencing this action for execution by the District officers. Motion was seconded by William Searfoss and carried unanimously, 8-0.

C. High School South Project Plan Revisions

ACTION BY THE BOARD:

Motion was made by William Zacharias that, with regard to the High School South Project: the Board direct its architect and/or engineers to revise its plans to provide for the installation of conduit for a future traffic light at the intersection of Maple Avenue and North Courtland Street; the Board agree to have an additional traffic study performed upon completion of the High School South Project to determine the necessity for a traffic light; and the Board authorize a payment or contribution to the Borough of East Stroudsburg of fifty (50%) percent of the cost of installation of a traffic signal, if the same is determined to be necessary based upon that traffic study, at such intersection, estimated of \$75,000.00. The Solicitor is authorized and directed to notify the Borough of this action and to prepare an appropriate agreement between the District and the Borough evidencing this action for executive by the District officers. Motion was seconded by Donald Motts and carried unanimously, 8-0.
