A. Field Trips - 75 Miles or More



AMENDMENT REGARDING TAX COLLECTION RATE

Motion was seconded by William Searfoss. Motion was made by Bet Hays to table amendment. Motion was seconded by Michal Peterson and carried, 5-4. A roll call vote was taken. Christopher Baj, William Searfoss, Donald Motts and Horace Cole voted against. Main motion was amended and carried, 5-4. Christopher Baj, Patrick Forney, William Zacharias and William Searfoss voted against.

ACTION BY THE BOARD: Main motion as amended carried, 5-4. A roll call vote was taken and Christopher Baj, Patrick Forney, William Zacharias and William Searfoss voted against.
