

ACTION BY THE BOARD:

Motion was made by Roland Featherman to authorize the Administration to work with Public Financial Management, as Financial Advisor, and Rhoads & Sinon, LLP, as Bond Counsel in conjunction with the issuance of approximately \$10,000,000 General Obligation Bonds, Series of 2003, as seen in Option 2 for the purpose of permanently financing the G. O. Note, Series of 2001, which was temporarily borrowed from the 1989 Emmaus bond pool program. Motion was seconded by Robert Huffman and carried unanimously, 5-0.

ACTION BY THE BOARD:

Motion was made by Roland Featherman to approve the application of *Pennsylvania Department of Education for the Non-Reimbursable Work Not Subject to Advertising Requirements* for the repairs to the concrete cornice of the J.M. Hill Elementary School. Motion was seconded by Don Motts and carried unanimously, 5-0.
