Article XIV requires that every child of school age be given by methods established by the State's Advisory Health Board, an annual vision test, a hearing test, a measurement of height and weight, tests for tuberculosis under medical Supervision and other tests required by the Advisory Health board. Children upon entry into school and in the 6th and 11th grades just have a medical examination and comprehensive appraisal of health by a physician. Children upon entry into school and in the 3rd and 7th grades must have a dental examination by a dentist. A comprehensive health record shall be maintained for each child.
