Prepare students for gainful employment as skilled workers or technicians in recognized, new and emerging occupations.</li> <li>2. Prepare students for enrollment in post-secondary education programs.</li> <li>3. Assist students in choosing meaningful career pathways.</li> </ol> <p>For purposes of this policy, <b>vocational, career and technical education</b> shall be defined as a series of planned academic and <del>vocational</del>, career and technical education courses articulated with one another to teach the knowledge and skills necessary to prepare students to effectively pursue recognized gainful employment.</p> <p><u>The Board shall ensure that all students and parents/guardians are informed of the student's rights to participate in career and technical education programs and courses and that students with disabilities enrolled in such programs are entitled to services under state and federal laws and regulations.</u></p> <p>The Board shall support a program of <del>vocational</del>, career and technical education which may include:</p> <ol style="list-style-type: none"> <li>1. <del>Vocational, e</del>Career and technical courses of study interwoven and articulated throughout the curriculum of the school.</li> <li>2. A cooperative education program which may offer students experience in private or public service employment.</li> <li>3. <del>Attendance at the Monroe County Area Vocational Technical School and District</del></li> </ol>

Students participating in cooperative education programs are not exploited, illegally employed, or employed under conditions that fail to safeguard their health and interests.</p> <p>5. Development of school district <del>vocational</del>, career and technical curricula is integrated with a continuing assessment of the employment demands of the community and the state, as well as the needs and interests of students.</p> <p><del>6.</del> Students and parents are informed that admission to <del>vocational</del> <u>career and technical education</u> programs is accessible to regularly enrolled students, in accordance with established criteria for admittance.</p> <p><del>7.</del> The Superintendent shall seek and utilize all available state and federal sources of revenue for the financial support of <del>vocational</del> <u>career and technical</u> education.</p> <p>All students participating in <del>vocational</del>, career and technical programs supervised by this Board or in vocational technical programs sponsored by this Board are subject to the policies and rules of the Board, and jointly established policies and rules of this school district and the Monroe <del>County Career and Area Vocational</del> Technical <del>Institute School</del>.</p> <p><u>Employers who participate in internship, externship, work study, co-op, or similar programs shall adopt policies and procedures that ensure compliance with procedures required by the Child Protective Services Law.</u></p> <p><u>Selection</u></p> <p>The following criteria may be used to select students to attend the <del>Vocational</del> <u>Monroe County Career and Technical Institute School</u>:</p> <ol style="list-style-type: none"> <li>1. Academic achievement.</li> <li>2. School Attendance.</li> <li>3. Attitude, behavior, and interest.</li> <li>4. Accuracy and neatness of a formal application.</li> </ol> <p><u>Removal</u></p> <p>Attending the Monroe <del>County Career and Area Vocational</del> Technical</p>

<p><del>School Code</del> 1106, 1212, 1801, 1806, 1808, 1809, 1841, 1842, 1850.1</p> <p><del>PA Code</del> Title 22 Sec. 4.13, 4.31, 4.32, 4.33, 4.34, 4.35, 11.28</p>	<p><del>Institute School</del> is contingent upon a satisfactory academic <u>achievement</u>, attendance, and/or disciplinary record at the home school or the <del>vo-career and technical</del> school.</p> <p><u>Transportation</u></p> <p>All <del>vocational-career and</del> technical students are expected to ride the school buses between the schools of the school district and the Monroe <del>County Career and Area Vocational</del> Technical <del>Institute School</del> unless a driving permit is issued by the Monroe <del>County Career and Area Vocational</del> Technical <del>Institute School</del> and/or school district. Students may <u>not</u> ride as passengers in vehicles with students who have been issued permits without administrative permission. This is granted only when accompanied by a parental note for legitimate purpose.</p> <p>In order to enforce this policy, school administration reserves the right to:</p> <ol style="list-style-type: none"> <li>1. Remove students from the Monroe <del>County Career and Area Vocational</del> Technical <del>Institute School</del> for unauthorized driving or unauthorized carrying of passengers.</li> <li>2. Remove students from the Monroe <del>County Career and Area Vocational</del> Technical <del>Institute School</del> for being an unauthorized passenger in a vehicle regardless if the driver has permission to drive or not.</li> <li>3.
