## **MINUTES**

- I. Meeting was called to order at 5:01 p.m.
- Policy Committee Members Present were: Robert Cooke, Robert Huffman, Wayne Rohner, and Judy II. Summers.

### IV. APPROVAL OF MINUTES

**ACTION BY THE COMMITTEE:** Motion was made by Robert Huffman to approve the minutes for November 21, 2016 (pages 1-2). Motion was seconded by Wayne Rohner and carried unanimously, 4-0.

### V. APPROVAL OF AGENDA

**ACTION BY THE COMMITTEE:** Motion was made by Robert Cooke to approve this agenda for December 19, 2016 (page 1), with members of the Committee reserving the right to add to the agenda and take further action as the Committee deems appropriate. - a. Policy #707 & 707A Use of Facilities—Discussion revolved around seasonal use and establishing limitations to prevent any one group from monopolizing a building. These limitations include: establishing the number of hours per week/per season to ten hours, that a season is defined to be a period not to exceed three months, and that requests for additional seasons not be permitted more than one month prior to the expiration of the approved season. Language was also clarified for the Class IV classification group. Class IV represents events, sponsored by PA registered non-profit business entities whose service area includes the ESASD, which directly benefit and/or advance the interests of district residents through programs or fundraising. Registered non-profit business entities can be verfied at www.corporations.pa.gov. All business entities not registered as non-profit will be classified as Class V.
- b. Policy #702 Gifts and Donations—Mr Bader shared current Policy 702 along with draft additions submitted by Chris Brown with regard to incorporating a section on advertising. Mr. Bader stated he anticipated that Mr. Brown would be in attendance to also share language with regard to sponsorships. In light of Mr. Brown's absence, Mr. Bader suggested that the committee review what was submitted to date and that he would obtain language for a section on sponsorships for the next meeting.
