a. J.T. Lambert Auditorium Ceiling Repaint

Robert Romagno stated that the ceiling in JTL has been on the District radar for quite some time. This is part one of auditorium renovations. Next Property and Facilities meeting should have carpet quotes. This project will be a complete paint job of the ceiling, using acrylic black paint. This is slated for summer of 2023, and Environmental Services has allocated funds to do this out of their budget.

b. Environmental Services New Equipment- LJC Janitorial Distributor

Robert Romagno that High School North and South have been demoing these machines from our current provider, LJC. We would like to purchase these machines as they are exactly what the department needs and they are the most affordable. If the District waits to purchase these, the cost will double in July. This originally was a discussion item but the committee did decide to vote on it.

c. Custodial Staffing Study-McCullough School Business Consulting

Robert Romagno received this quote, this is a study for the District to see if the District is properly staffed in each school building. This will study the amount of labs, sinks, toilets, etc. within the District. Having a 3rd party person evaluating the staff and District will solidify if we are properly staffed. This study will be coming out of the Environmental Services general operating budget.

d. Fire Protection 3-Year Agreement

Fred Mill spoke about our current Fire Protection Agreement will expire very shortly. We currently are contracted with Cintas, who is unable to provide us with all the services the District requires. Keystone Fire is the only vendor who can work on Honeywell parts. If the District agrees to a long term agreement with Keystone Fire, there will be no need to outsource like Cintas currently does.
