b. Bushkill Elementary Fuel Oil Tank - Crompco

Daryle Miller stated this is not a planned repair. The tank is filling with water. Crompco will drain and inspect the tank to find out what exactly is wrong with it. This is an investigation repair. Assuming there is a leak in the tank, Crompco will come back with more information and additional pricing for repairs. There is a 4-6 week lead time for Crompco to come and inspect the tank.

VII. ITEMS FOR DISCUSSION

a. North Campus Chillers - Trane

Daryle met with Trane and there are two chillers that are 24 years old and need reconditioning. This is just a discussion because of the cost. As some point, there will be no choice but to replace these two chillers. If these are replaced, Trane will do this work in the winter months. These chillers are the ones by the baseball field at High School North. This is a budgetary proposal. If we want to move forward a new invoice will be generated and Trane will come to the meeting to help answer any questions the committee may have.

b. North Water Tower Generator - Critical Systems

This generator has a blown head gasket. Critical Systems is a current contracted vendor for our generators within the District. Critical Systems provided two different options.

Larry Dymond stated we need to have a tank that is big enough that if it's zero degrees out that the propane will still come out. Bushkill should be like Resica.

Jason Gullstrand asked the status of the Lehman baseball field. With all the rain we had they haven't been able to utilize the field.
